THE JOKES are always made about the Smiths or the hard-to-keep-up-with Joneses. Actually there are more Millers in the telephone books than all the Smiths and Joneses put together. In these East Hampton genealogies, the Millers take up the most space, with the Edwards family a close second. Back in 1936 there was a moving picture, "Ah Wilderness," about a typical American family named Miller. When it came to East Hampton any man or woman bearing the surname Miller was admitted free, with the proviso that a non-Miller friend was brought along.

East Hampton has always had Millers. They owned places at Jericho, Apaquogue, on what is now Jeffreys Lane, Woods Lane, Main Street, Three Mile Harbor, Fire Place, The Springs, and Amagansett. They have been heroes in war and peace. A Miller who moved away served as Surrogate of New York County. Five generations of Millers who moved upstate to Utica served as State Assemblymen; and former Governor Nathan L. Miller of New York State was descended from East Hampton

Millers.

Eleazer Miller was Supervisor of the Township in 1739; he was elected to the Colonial Assembly in 1748, serving continuously until 1769. His son Burnett was Town Clerk from 1747 to 1777, Supervisor from 1764 to 1776, lacking one year; was a member of the Fourth Provincial Congress, and a representative in the State Legislature, 1777–1783. Abraham Miller was elected Supervisor in 1789, 1799, and 1803, and served for some years as Town Clerk. Jeremiah Miller was also Town Clerk, 1784; Samuel in 1831; Charles H. Miller was elected Supervisor, 1840; and George Asa Miller served continuously as Supervisor from 1887 to 1913. He was Chairman of the Suffolk County Board of Supervisors.

The late George Asa Miller's children are double Millers, since their mother was Alice Maria, daughter of Samuel David and Ruamah Anna

Simons Miller of Fire Place, The Springs, East Hampton.

The writer has puzzled for nearly a year over the early Millers; this family alone could become a life study. After searching through hundreds of documents and scores of books, sifting out Millers, the conclusion is that their origin will always be a matter for controversy. The help of Dr. F. A. Finch's notes is gratefully acknowledged. And generous assistance given by Mrs. Daniel T. Miller of The Springs. Daniel T. Miller, Jr., a grandson of George Asa Miller, has made a distinguished contribution to Miller family history in a paper written in May, 1952, a history of the early family with genealogy of his own branch; it is based upon research done by his mother and by Miss Grace Farwell of the E.H. Free Library, is well written and well documented; it includes family

anecdotes which make pleasant reading. With permission of the writer the following statements regarding the family's origin are quoted:

"The Miller family came to East Hampton when the town was first settled. Much has been written about the Millers, but much is incorrect and contradictory. There have been so many John Millers that it is difficult to tell to which the records refer. It is probable that several families of Millers came here about the same time, although historians have grouped them all together as one family. No Church records were kept by the first minister (Minister James)." (Note: The writer has read somewhere that Thomas James did keep records, but they were lost in a fire.) "This adds to the difficulty in checking early traditions. The Town Records were carefully kept. These have been the source of much information about the early families.

"The Miller family came to East Hampton from New England. The first to come here was John Miller. He is said to have come by way of Lynn and Salem, Mass., about 1643, stopping in Southampton before settling in East Hampton in 1649 or 1650." "Some historians say that John Miller came from Maidstone, England," "others say that he came from Craig Miller, Scotland. Old family tradition gives the line as Scotch in origin. This belief has been handed down in two branches of the family,

George Asa Miller's and Timothy and Gilbert Miller's.

"Hedges, in his History of East Hampton, states that 'there is a tradition that the first settler of this family was John Miller, who died soon after settling here; that his wife was daughter of Minister Abraham Pierson; and that he left sons John, Andrew, and George.' History of the Pierson family shows that this is not possible. Abraham Pierson's daughter Mary was born between 1660 and 1665; her marriage is not given." "Her name may have been Mary Pierson, but she was probably not the

daughter of Abraham Pierson.

"In 1648, Governor Eaton bought the land from the Indians to be conveyed to the settlers in the spring of 1651. In the list of names in the conveyance is John Miller. The remaining land was purchased in 1660. The list then includes John Miller and George Miller. John is mentioned in 1655, and in 1656 an entry in the Town Records states that 'John Miller, Andrew Miller, and George Miller are added to our Combination.' This was an association of the early settlers of the town. Some believe this was the first John. If so, he could not have been the father of George and Andrew. If there were an earlier John, as historians say, he must have died soon after coming here, for he is not mentioned in later records.

"John and Andrew are known to be brothers. They are so mentioned in the early records. Andrew lived in East Hampton until 1670 or 1671, at which time he left town and settled at Miller's Place, Long Island.

"William Miller is believed by some authorities to be brother of John and Andrew. He may possibly have been Andrew's eldest son. William

and his wife Hannah sold all their property in East Hampton in 1693 and moved to Elizabethtown, New Jersey. Closely connected with this family were the children of a John Miller from Long Island. These two families were among the founders of Elizabeth and Westfield, N.J. There is evidently a close connection with Andrew Miller's family of Miller's Place.

"George 2, son of John 1, was in Southold, L.I. before coming to East Hampton. His home there was on the lot on which the Universal Church now stands. In 1656 he sold his property in Southold and moved to East Hampton. He owned much land in East Hampton." "John is his eldest son and heir.

"After John 3 becomes old enough to appear in the tax lists, his name is written 'John, Jr.' to distinguish him from the elder John 2, who is then called 'John, Sr.' "John 3, s. of John 2, does not appear in the E.H. records, probably because he owned no property in E.H. and later went to Cohansey, New Jersey. 'John Sr.' always signs his name, but 'John, Jr.' makes his mark; so it is easy to distinguish between them in the records.

"John 3, son of George 2, married Elizabeth Dimon. Their children were Jane, John, Thomas, who died at sea in 1699, Experience, and possibly Daniel. Hedges says that Daniel 4 is probably the son of John 3. Family tradition disagrees with the historians. George Asa Miller said that he believed Daniel to be a descendant of John 2's son John instead

of George 2's son John.

"According to family tradition, seventy or more years ago there were two separate families of Millers, the dark haired and the light haired Millers. The dark haired Millers were tall, angular and muscular, and of Scotch descent. The light haired Millers were short and stocky, and of English descent. They believed George 2 to be unrelated to John and Andrew. They believed that Eleazer Miller, the Assemblyman, and the other descendants of George 2 were not related to the dark haired descendants of Daniel 4.

"Historians give the line as John 1, George 2, John 3, Daniel 4. If George Asa and family traditions are correct, the line would run John 1, John 2, John 3, Daniel 4. Mrs. Alma Von Hoevenberg, genealogist for Mrs. Jay Gould (Helen Day Miller) and Mrs. Finley J. Shepard, also has the line John 1, 2, 3, Daniel 4. The Genealogical and Family History of the State of Connecticut states that John Miller came from Maidstone, England"—"and settled at Lynn, Mass.; that he was also for a time at Salem before coming to East Hampton in 1649.

"The Genealogy of Southern New York states that John Myller and his wife Mary came from Craig Miller, Scotland, and that George Myller, their son, came with them. However, they list the allotments of John 2 for this John and describe the activities of John 2. The author has con-

fused the two Johns as well as George's descendants.

"John 2 signed the Combination in 1657. The allotments of land granted him by the Town of E.H. are listed in the Town Records. An early lot was located on Woods Lane, the third lot from Calf Pasture Lane, now Ocean Avenue. This was later exchanged for land elsewhere. He was a farmer as well as a whaleman. His associate in the whaling industry was Renick Garrison (Renick the Dutchman). In 1666 they were granted privileges of Accabonac Harbor for seven years. Seven years later, John Miller brought action in behalf of his company of whalemen to collect a debt. Many from East Hampton went to Cape May, New Jersey and to Cumberland County, New Jersey, for the purpose of whaling in Delaware Bay. Some settled at Cohansey, later known as Greenwich, on the Cohansey River. In 1698 John 2 and his wife Mary sold all their property in East Hampton and moved to Cohansey. The original deed of sale to Jacob Schellinx is among George Asa's papers. He must have died soon after settling in New Jersey, for his will was proven there Nov. 3, 1699."

"John Miller 3 of Cohansey, whose will was proven May 17, 1749, is the son of John 2. This is the John whom George Asa Miller and Mrs. Von Hoevenberg believed to be the father of Daniel 4."

"The names of John Miller, Noah Miller and others from E.H. are in

the list of early settlers on the north bank of the Cohansey."

"Daniel Miller 4 married Elizabeth Buckland on Dec. 13, 1699. They

lived at Fulling Mill Farm and later at Apaquogue."

And so forth. A copy of the paper by Daniel T. Miller Jr. will doubtless be preserved in the Long Island Collection at the E.H. Library and deserves reading in full.

The writer is inclined to go along with the majority of historical writers and to credit Daniel Miller 4 as a son to John 3, son of George 2, and to explain the dark strain and the fair strain to a difference, perhaps, on the maternal side generations ago. But that is just one opinion.

In spite of the length of this Miller genealogy, it is by no means complete. But it will furnish a solid background for research by future family historians.

JOHN MILLER 1 m. Mary (a Pierson, probably;) ch. George 2 (probably) b. 1630, d. 1668; Andrew 2 b. 1634 d. 1717, John 2 who d. 1699, perhaps William 2 who d. 1711, who rem. to N.J.; Susanna 2 (she is said to have m. Dr. George Filer, 1663; but if so, she died early for Dr. Filer m. Edith Shaw, 1665).

GEORGE 2* b. 1630 d. 1668 from the kick of a horse; m. 1650 Hester, dau. Ananias and Mary Lavender Conkling, she b. 1632 or 1635; ch. John 3 b. April 1654 d. Dec. 5, 1738; Lieut. Jeremiah 3 b. 1655 d. Jan. 2, 1723; George 3 b. 1660 d. Oct. 12, 1712; Cornelius 3 b. 1662 d. April 5, 1735 or 1755; and Mary 3 b. 1668 (who m. Robert Hudson).

*George 2 owned a great deal of land; in 1665 he bought Thomas Rose's property. Some genealogists say George 2 was son of John 1 and ancestor of all early Millers in E.H. Others maintain that he came from Southold and was of an entirely different family.

- ANDREW 2* b. 1634 d. 1717 at Miller's Place, L.I. where he rem. 1671; he m. Margaret ———. Ch. Andrew 3 who d. 1716, John 3 who drowned, ae 28; Samuel 3 who rem. to Greenwich, N.J., Richard 3 and Hannah 3, who d.y.
- *In 1664 he was living on Gardiner's Island and sold his house and land to Jeremiah Conkling. Yet in 1668/9 he was allotted 8 acres of woodland near Two Mile Hollow next to his brother John's, if he would make whale-oil casks for town use (he was a cooper); but he had to live in E.H. three years before the land was his to sell. Mrs. Norman J. Bruen of Wading River, L.I. has a genealogy of this line made by Martha Helme Miller, 1912.
- JOHN 2 d. probably 1699 m. Mary* (surname unknown); ch. Noah 3, John 3, Preserved 3, Mary 3 (who m. Thomas, s. of Richard Stratton) Susannah 3 (who m. Jonathan Holmes), Hester 3.
- *In 1668 an Indian was tried in Hartford, Conn. for an attempted attack on Mary, wife of John Miller of E.H. In 1678 a John Miller was accused by Isaac Halsey of Southampton of horse-stealing. The court ruled that both plaintiff and defendant should bear court charges equally, and that the horse should remain in Town custody. John 2 was very active in offshore whaling (see introduction, Millers) and in 1685 he and Jacob Dayton made an agreement with the Indians for whaling, John and Mary Miller sold land, July 16, 1698, and rem. to Cohansey, near Elizabethtown, N.J.
- *He is mentioned in E.H. Town Records from 1667 to 1693; N.J. Genealogy and Hatfield's History of N.J. give further information about him. He owned property on Newtown Lane, E.H., and near Hook Pond; sold land 1693, and rem. to Elizabethtown, N.J.
- JOHN 3* (s. of George 2) b. April 1654 d. Dec. 5, 1738, m. 1677 Elizabeth, dau. Thomas and Mary Howell Dimon; she b. 1658, d. Jan. 6, 1736/7; ch. Jane 4, b. 1677, (who m. Beriah Dayton;) Thomas 4 b. 1679, d. at sea June 8, 1699; Daniel 4 b. 1680, John 4 b. 1685, rem.; Experience 4 b. 1682 (who m. John Talmage Dec. 25, 1702;) Jerusha 4 b. 1685 (who m. John Wickham Feb. 4, 1703), Martha 4 b. 1690 (who m. Stephen Hand, 1712).
- *In Allotments, Book III, EHTR (1713): John, "brother of George, uncle of Hezekiah and Nathan" has land at Wainscott; also at Northwest and Accabonac Neck. He had a warehouse and landing place at Northwest, 1709–10.
- LIEUT. JEREMIAH (JEREMY) 3* (s. of George 2, John 1) b. 1655, d. Jan. 2, 1723, m. 1685 Mary, dau. John Mulford; she b. 1653 d. Oct. 9, 1748; ch. Josiah 4 b. 1689 d. Oct. 4, 1770; Jeremiah 4 b. 1690 d. March 15, 1756, Eleazer 4 b. 1697 d. March 15, 1788.
- *He was a large landholder, with property at Wainscott, Northwest, on "Ye Eastern Plaine", and at Amagansett; a Town Trustee.
- GEORGE 3 (s. of George 2, John 1) b. 1660 d. Oct. 30, 1712, m. 1684 Martha, dau. William and Sarah Ayers Mulford; she b. 1665, d. Aug. 21, 1752; ch. George 4 b. 1685, d. 1770; Hezekiah 4 b. 1687 d. Oct. 26, 1747; Nathan 4 b. 1689 d. Nov. 29, 1749, Prudence 4 b. 1690 m. John Cornell or Cromwell Oct. 14, 1708; Jerusha 4 b. 1705 (who m. Ebenezer Leek Jr. June 14, 1723); Phebe 4 bapt. 1706.
- CORNELIUS 3 (s. of George 2, John 1) b. 1662, d. April 5, 1755, m. Deborah, dau. John Goff, 1690; ch. Cornelius 4 b. 1691, who became a clockmaker and rem. to Queens County; Margaret 4 b. 1696 (who m. Nathan Cooper Oct. 8,

1716;) a child d. 1703; Elizabeth 4 b. 1704 (who m. Jacob Schellinger May 14, 1724;) Mercy 4. Cornelius and his dau. Mercy joined the church, 1724.

DANIEL 4* of Apaquogue, Jericho, or Georgica—the family owned a large tract in all three districts of E.H.; (s. of John 3, George 2, John 1) b. 1680 d. Dec. 13, 1769; m. Dec. 13, 1699/1700 Elizabeth, dau. John Ludman of Hartford, Conn. and widow of John Buckland; she d. Dec. 16, 1756; she had a ch. John by previous marriage, he d. 1703 ae 5. Ch. Experience 5 b. 1702 (who m. Elias Hand Nov. 6, 1729), Elizabeth 5 b. 1703, d. inf.; John 5 b. 1707, Daniel 5 b. 1709, d. 1711; Timothy 5 b. June 6, 1713 (Judge Hedges says June 4, 1710) d. Sept. 4, 1770; Alethea 5 b. 1716, (who m. Benjamin Hedges of Montauk June 16, 1741;) Elizabeth 5 again b. 1721, (who m. John Merry Jr. Feb. 19, 1739.)

*Daniel 4 was prominent in E.H. town affairs from 1700 for over 40 years. With his sons and negro slaves, he took a whale and sold enough oil to buy a 40-acre farm between Old and New Fireplace, The Springs, with all buildings, fenced, on which he settled his "dearly beloved and dutiful son" Timothy 5; John 5 remained on the family homestead at Apaquogue. Land at Apaquogue, E.H., had been allotted and was settled by 1652. Deeds for purchase of Fireplace, and the deed of gift to Timothy are still preserved in the family. Daniel 4 was on the muster roll of the Suffolk Regt. 1715.

JOSIAH 4* (s. of Lieut. Jeremiah 3, George 2, John 1) b. 1689 d. Oct. 4, 1770, m. 1712 Phebe, dau. Edward and Elizabeth Chatfield Jones, she b. 1696, d. Sept. 12, 1758; ch. Josiah 5 b. 1721 d. Aug. 5, 1772, (who inherited home lot and lands); Jeremiah 5 b. 1727 d. July 11, 1794; Phebe 5 b. 1718 m. May 15, 1740, John Parsons; Martha 5 b. 1721 (who m. Jonathan Fisher Jan. 24, 1739; Jerusha 5 b. 1724; Matthew 5 b. 1730 d.s.p. April 10, 1810; he was a cripple; Jane 5 b. 1733, Phebe 5 b. 1736, d. 1738.

*Josiah 4 was a Trustee, Assessor, and Overseer of the Poor for E.H. Town; he was a member, 1715, of the Suffolk Regiment. In 1711 he was member of an off-shore whaling company with John Gardiner and Samuel Mulford. He left two tankards, one to daughter Phebe, one to son Jeremiah 5. Phebe's went to her daughter Mary 6, w. of Jeremiah Osborn; thence it passed to his d. Phebe P. 7 w. of Zephaniah Hedges, and thence to her s. Henry P. Hedges 8, and to his s. Samuel O. 9. Jeremiah 5 gave his tankard to his s. Jeremiah 6; and he to his s. Gen. Jeremiah 7, and he to his s. Jeremiah 8, and he to his nephew Jeremiah Miller Dominy 9. Chriss, negro servant of Josiah Miller, and her children Brin and Turab were baptized 1736.

JEREMIAH 4 (s. of Lieut. Jeremiah 3, George 2) b. 1690 d. March 15, 1756, graduated from Yale 1709, rem. to New London, Conn., where he became a distinguished citizen. He m. March 1, 1718 Mary, dau. of Governor Saltonstall; ch. Jeremiah 5 b. Aug. 23, 1719, Joseph 5, and Jason 5 b. July, 1731.

ASSEMBLYMAN ELEAZER 4* (s. of Lieut. Jeremiah 3) b. 1697 d. March 15, 1788; m. Jan. 1, 1719 Mary, dau. Capt. Matthias and Elizabeth Osborne Burnett; she d. April 14, 1743 ae 42. Ch. Burnett 5 b. Oct. 15, 1719, Elizabeth 5 b. Nov. 28, 1721 (who m. Elisha Jones June 29, 1746;) Jeremiah 5 b. Jan. 11, 1723, Mary 5 b. Sept. 12, 1726, (who m. Jan. 1, 1748 Stephen Hedges;) Jemima 5 b. May 28, 1730 (who m. Jan. 11, 1748 Thomas Talmage), Mehitabel 5 b. April 13, 1733 (who m. David Baker); Eleazer 5 b. March 30, 1736, Ananias 5 b. 1738, Nathaniel 5 b. Dec. 9, 1738, Ann 5 (who m. John Taylor of N.Y. City,) Judge Abraham 5 b. Jan. 16, 1742 d. March 19, 1820.

*Eleazer Miller 4 was elected to the Colonial Assembly 1748 and served continuously until 1769; he is always referred to in E.H. Town Records as "Esquire." His son Burnett was E.H. Town Clerk for many years, Supervisor of E.H. Town 1764-1776 lacking 1 year; and a member of the 4th Provincial Congress. He was a Representative in the N.Y. State Legislature 1777-1783.

GEORGE 4* (s. of George 3, George 2, John 1) b. 1685 d. 1770 m., 1714, Sarah, dau. Capt. Cornelius and Mary Dayton Conkling, she b. 1692, d. May 12, 1747; ch. Joseph 5 b. 1716, Benjamin 5 b. 1718, Sarah 5 (who m. Zebulon Bennett May 9, 1738;) Martha 5, b. 1721 (who m. Jonathan Fisher;) Lucy 5 b. 1723, Rhoda 5 b. 1725 (who m. Daniel Talmage 1743;) Abner 5 b. 1727, Jonathan 5 b. 1729, d. 1758; George 5 b. 1731, Jane 5 b. 1735 (who m. 1753 Jeremiah Bennett;) Phebe 5 b. 1736, d. 1738.

*Perhaps he did not live in E.H. before his marriage; in Conkling genealogy is a note saying that Sarah Conkling m. George Miller "of Southampton." It is likely that he lived in Wainscott or Sagg—perhaps just over the Southampton boundary line.

HEZEKIAH 4 (s. of George 3, George 2, John 1) b. 1687, d. Oct. 26, 1747. (A Sherrill genealogy says b. 1683, d. Sept. 1, 1720) lived in Wainscott, according to 1708 records. He m. July 22, 1707/8, Elizabeth, dau. Samuel and Elizabeth Parsons Sherrill, she b. 1688, d. 1755; ch. Henry 5 b. 1710, Jane 5, b. 1711, (who m. Thomas Filer 1733;) Keturah 5 b. 1715 (who m. Ebenezer Jennings May 11, 1737;) Joanna 5 bapt. 1716, (who m. Ezekiel Hand Dec. 14, 1737;) Thomas 5 b. 1716, Jacob 5, Hezekiah 5 b. 1727; and 4 ch. who d. under 12 years of age.

NATHAN 4 (s. of George 3, George 2) owned land both at Wainscott and at The Springs; he was b. 1689, d. Nov. 29, 1749, m. Mary, dau. John and Rachel Hedges Conkling March 13, 1710, she b. 1692, d. Jan. 16, 1750; ch. Mary 5 b. 1711, d. 1750, (who m. Ananias Conkling Jr. Feb. 5, 1732;) Phebe 5 b. 1713 (who m. Henry Hedges Oct. 19, 1735;) Nathan 5 b. 1716, who d.s.p. at sea Jan. 18, 1738; Uriah 5 b. 1721, Rachel 5 b. 1723, d. inf.; Rachel 5 again b. 1725 (who m. Daniel Dayton Dec. 17, 1754;) Esther 5 b. 1729 (who m. Abraham Hedges Oct. 25, 1747;) Amy* 5 b. 1732 (who m. 1st Edward Mulford, Jan. 1, 1750; and m. 2nd. Ezekiel Mulford Jan. 1, 1756;) Abraham 5 b. 1736 d. ae 2; Abraham 5 again b. 1746.

*"Amy's Lane" which comes into the Montauk Highway at Pantigo just east of Mrs. Mary Barnes Welby's place, was named for Amy Miller Mulford; that place was then home of the Ezekiel Mulfords. Geoffrey Bass who rents the place (1952) says that the foundation of a very old house is visible next to Amy's Lane, up the hill from his home.

JOHN A. 5 (s. of Daniel 4) b. March 16, 1706/7, d. March 1, 1791, buried in the Jericho cemetery m. 1st Patience Paine Jan. 29, 1728/9; she d. 1732; he m. 2nd., 1733, Mercy, dau. Lewis and Mary Bishop Conkling, she b. 1709, d. 1744; he m. 3d. Rebecca, dau. Stephen Kempton of Southampton, she b. 1717 d. 1807. Ch.: Matthew 6 b. 1730, Daniel 6 b. 1732, Mercy 6 b. 1735, Lewis 6 b. 1736, John 6 b. 1739, d. Nov. 11, 1808, Enoch 6 b. 1746.

LIEUT. COL. TIMOTHY 5* (s. of Daniel 4, etc.) b. June 14, 1713, d. Sept. 4, 1770; m. 1st, Oct. 30, 1734, Temperance, dau. David and Mary Mulford Conkling, who d. Nov. 23, 1740 ae 28; and m. 2nd., July 30, 1741, Hannah, dau. John Stratton Jr., she b. June, 1717; d. May 7, 1784; ch. Philip 6 b. 1735, d. ae 3; Zerviah 6 b. 1736 (who m. Jonathan Hedges and d. March 8, 1792;) David 6 b. 1737, d. inf.; Temperance 6 b. 1742, Timothy 6 b. 1744, Elizabeth 6 b. 1747, (who m. Daniel Hand 6 and rem. to Richmond, Berkshire Co., Mass.); David 6 again, b. 1748 (he inherited house and home lot at Fire Place), Elisha 6 b. 1750, Hannah 6 d. inf.; Hannah 6 again b. *Timothy 5 lived on Gardiner's Bay at Fireplace, where a signal fire used to be built when a ferry boat to Gardiner's Island was needed. There were buildings

on the place when Daniel 4 bought it for his son; and it was fenced. Last occupants of the old Miller house were Samuel David Miller 8 (1827–1918) and his wife Ruamah Simons (1832–1913). The old house burned down about 1925; the property now belongs to Mrs. Adelaide Mershon Purcell who has a girls' camp there,—Fire Place Lodge. Timothy 5, Elisha 6, David 6, are buried at Cedar Lawn, E.H. Lt. Col. Timothy Miller fought in the French and Indian War. His commission dated 1748, hangs in the Miller homestead at The Springs.

*Gen. Jeremiah was East Hampton's first Postmaster in 1816. He bought the property on Main Street now owned by Mr. and Mrs. Franklin M. Chace, from Aaron Isaacs, grandfather of John Howard Payne, who lived across the street in what is now the Presbyterian Manse. The house then stood close to the street. Timber for the house was cut on Gardiner's Island 1809; the logs were left in the street to season for two years. A north wing housed the Post Office; John Howard Payne wrote letters to his "childhood sweetheart" Joann; these letters, speaking of Mrs. Miller's apple pie and of friends in the village are preserved by Mrs. Rosalie Miller Baker Swezey. *Samuel H. 9 was an outstanding character who dearly loved a joke and never forgot a good story. He wrote many articles on local history for the E.H. Star. His wife was an orphan niece of Abraham D. Candy, an Englishman who came to teach in Clinton Academy and helped John Wallace found the Episcopal Church here. Candy opposed his young niece's marriage, so she eloped at sixteen, and he never spoke to her again. When he died in 1880 a little trunk with her clothing and music books was found in the house. Laura Candy Miller was first organist in the Episcopal Church here. Samuel H. Miller, with his friend Theodorus Miller Stratton, once wrote a novel based on his wife's uncle, but it was never published.



The writer takes no part in the dispute concerning Temperance, who married first Capt. John Penny and married second Benjamin Hubbard King. She became the mother of Capt. John Penny (1834–1926), and also of Remington King of East Hampton and others. One faction today says: "Aunt Tempy' was a Bennett, tall and rawboned like all that branch of the Bennetts"; another faction says: "She was a Miller; and there is a record of her marriage to John Penny in the Sag Harbor paper which says so." She was born March 23, 1812 and died May 17, 1891. Neither side can produce a family Bible record to prove her parentage. Her young husband and three other men, all related, drowned in Gardiner's Bay at high noon in the spring of 1834. See King genealogy.

OTHER MILLERS

Millers have played an important part in Long Island history, in places other than East Hampton. Andrew Miller who founded Miller's Place,

L.I. 1671 went there from East Hampton. There was a Judge George Miller (1799–1883) educated at Clinton Academy who organized a church and a girls' school in Riverhead. Another descendant of Andrew Miller, one who was known and loved in East Hampton, was the late Elihu Sanford Miller of Wading River, L.I. (1848–1940) botanist and author of papers on botanical subjects. Mr. Miller attended Clinton Academy, where he met Mary Esther, daughter of Capt. Jeremiah and Mary Hedges Mulford, and married her in 1875.

"Mary Esther" taught school at Montauk—Third House—as a girl; she was a newspaper columnist for fourteen years while living at Floral Park, N.Y. "Talks With Girls" her column was headed. Then they settled in the old Mulford house in Wading River, built by Zophar Mills Miller 1799 and lived there happily together until her death on May 15, 1938. They never lost touch with friends and family in East Hampton. Mrs. Miller celebrated her 89th birthday on Feb. 3, 1938 with the publication of "An East Hampton Childhood," a charming small book of stories told by Mrs. Miller to Miss Abigail Fithian Halsey of Southampton.

Space forbids going deeply into the Wading River Millers' genealogy; but the memory of Elihu and Mary Esther Mulford Miller will live on in East Hampton, and in Wading River where their daughter Emily Mulford Miller (now Mrs. Norman Jay Bruen) occupies the beautiful old homestead, and their son, William Leggett Miller, lives nearby. Both, like their parents, take a lively part in community and Long Island affairs. Genealogy of that branch of the family may be found in the E.H. Library.
