## STRONG

THE STRONGS came from Taunton, England to New England in 1630. and Thomas Strong, fourth generation, settled in Wainscott shortly after 1700. The oldest part of the house occupied by Charles Strong until his death in 1942 is said to have been built as a shop in 1695, prior to any real settlement in Wainscott.

Miss Mary Strong, Mrs. Morgan Topping, Edward M. B. Strong, William Hedges Strong, and Dr. Frederick A. Finch have furnished most of the material for the following Strong genealogy.

ELDER JOHN STRONG 1 b. 1605 in Taunton, England, came to New England in 1630 on the ship "Mary and John", landing at Nantucket. He went to Dorchester, Mass. in 1635, then to Hingham, Mass. and Windsor, Conn.; and in 1659 became one of the founders of Northampton, Mass. He lived there for some forty years and was known as Elder John Strong. His first wife's name is unknown; he m. 2nd Abigail Ford in December, 1630. He died April 14, 1699. His wife died July 6, 1688. One of his eighteen children was Thomas born 1630 or 1633 and died Oct. 3, 1689. Thomas 2 was a trooper, 1658, at Windsor, Conn. under Major Mason.

THOMAS 2 b. 1630 or 1633 d. 1689, m. 1st Dec. 5, 1660 Mary, dau. of Rev. Ephraim Hewitt; he m. 2nd Rachel Horton.\* He had 16 ch.; Thomas 3 became ancestor to the East Hampton branch; Selah 3, b. at Northampton, Mass., 1680, was ancestor of the Setauket, L.I. branch and the Orange Co., N.Y. branch.

THOMAS 3 (s. of Thomas 2, John 1) b. Nov. 16, 1661, m. Nov. 17, 1683 Mary, dau. of John and Abigail Bartlett Stebbens or Stephens of Northampton, Mass., she b. Sept. 10, 1666. He was a farmer and rem. to Durham, Conn., after 1708. One of his ch. was Thomas 4 of East Hampton.

SELAH 3 (s. of Thomas 2, John 1) b. Dec. 22, 1680 d. in Brookhaven, L.I., 1732; m. Abigail Terry of Southold, L.I. Among his ch. were Thomas 4 of Setauket, L.I., Selah 4, Benajah 4; this branch belongs to Setauket, L.I. and Orange Co., N.Y. and does not belong in this East Hampton genealogy.

THOMAS 4 (s. of Thomas 3, 2, John 1) b. Aug. 27, 1686, d. Feb. 8, 1772, was a carpenter; he lived in Wainscott; m. Mary, dau. of Ephraim and Elizabeth Miller Osborn, she b. 1694 d. Feb. 5, 1779. Four of their ch. were: George 5 b. 1723, John 5 b. Nov. 9, 1726, and twins, Mary 5 and Abigail 5, bapt. April 30, 1732.

JOHN 5\* of Wainscott (s. of Thomas 4) b. Nov. 9, 1726 d. May 28, 1808, signed the Association in 1775 and served in the Revolution in Connecticut; he m. June 1, 1753 Martha, dau. of John and Experience Miller Talmage, she b. Oct. 2, 1729 d. July 25, 1811; ch. Anna 6 b. March 31, 1754, (who m. a Leek), John

- 6 b. Dec. 3, 1756, d. Jan. 1, 1828; Mary 6 b. Nov. 2, 1759, d. 1835; Talmage 6 b. Nov. 2, 1761.

- \*Edward M. B. Strong says that Thomas 6 lived on Woods Lane, E.H.; his was the first Strong house in the village, built 1810, where Charles S. Tillinghast lives now. Miss Abigail, 7th gen., was last to live there. Mr. Strong has (1952) her clock and the key to the front door. Thomas 6 had a cattle earmark registered Oct. 24, 1822, gift of his father-in-law.

\*William H. Strong went to California in the Gold Rush with other young men from Amagansett,—Erastus Leek, Abraham Leek, Henry L. Van Scoy, Silas Sherman, and George W. Schellinger; and John Miller of East Hampton, on the Hamilton, Capt. Shamgar H. Slate., sailing Oct. 5, 1849 from Sag Harbor, arriving in San Francisco March 14, 1850, round Cape Horn; never touching land but at Robinson Crusoe's Island, Juan Fernandez. It was the Strong-Baker house built by Nathaniel Baker, 5th gen., that Mrs. Harry L. Hamlin bought and moved from Main Street, Amagansett to Stony Hill Farm, Town Lane, Amagansett; it is now owned by Jeffrey Potter.
