DIMON

DIMONS STILL live in Southampton, but the name, represented in East Hampton for two hundred and fifty years, has died out here. It was formerly spelled in various ways, as Diament, Dymont, Diamont, Dimond, and Deming; but descendants of the early settler in East Hampton now spell the name Dimon. George Rogers Howell's History of Southampton (1887) says that John and Thomas Deming or Diamont first appeared in Wethersfield, Conn. records in 1635–45, and that they were probably brothers. Also, that the name is probably derived from Dumont and was the family name of a Frenchman who emigrated to England. A Dimon genealogy published in Albany, N.Y. 1891 was written by Edwin H. Dimond of San Francisco, and is in the Pennypacker L.I. Collection at the E.H. Library.

There seems to be no record of where or whom the first Thomas Dimon was born. Teunis D. Huntting, in his genealogy of that family, says that he came to East Hampton from Lynn, Mass.; but if so he must have been in Lynn very early, for it is on record that he married Mary Sheaff or Sheaffe in Wethersfield, Conn. on July 24, 1645 and his son James was born there in 1646. Thomas Dimon (or Deming's) shipyard in Wethersfield, 1648, is mentioned as the place where one of the first ships of the colony, the Tryall, was built. Thomas removed with his family to Farmington, Conn., thence to Southampton, where he was granted land in 1659, and came to East Hampton in 1663, remaining here.

THOMAS 3 (s. of James 2) b. 1680 d. April 18, 1754, m. Jan. 1707 Hannah Finney; ch. James 4, John 4 bapt. Oct. 1707, Rebecca 4 bapt. 1709, Jeremiah 4, Jonathan 4 bapt. 1712. In 1712 this branch rem. to Bristol, R.I. where other ch. were born, Phebe 4, Lucretia 4, and Daniel 4.

NATHANIEL 3 (s. of James 2) b. 1682 m. Lois Hedges, 1721; ch. Jonathan 4, Jane 4, Lois 4, all b. in E.H. This family rem. to Vermont 1727.

17, 1718 who d. Feb. 18, 1722, m. 2nd. Eliza Davis Dec. 25, 1722 who d. Sept. 12, 1729; he m. 3d. Rachel Dayton, 1730; who d. Aug. 7, 1762; ch. Deborah 4 bapt. 1724 (who m. 1st. 1747 Stephen Conklin and m. 2nd. a Miller;) Elizabeth 4 bapt. 1726 d. 1727; John 4 bapt. 1727, Elizabeth 4 bapt. 1731 (who m. a Hand); Rachel 4 bapt. 1733, Abraham and Isaac 4, twins, bapt. 1736; Mary 4 bapt. 1742, Eliza 4 bapt. 1745.

*In the will of John 3 the name was first spelled Dimon. In Trustees Records, 1725-1772, p. 105 is this note: "1747 May 26th, Sold a piece of Common land (by way of Publick vendue) to John Dimon lying between said John Dimons dwelling house and the first Crick containing about nine acres, including a quarter of an acre which was alowed him for half an acre taken of his land at the Line, for which he geives Eleven pounds; the highway to be five poles wide at the narrowes place against Joneses land and four rods at the Sand hil at ye Southwst end——"

The Dimons lived at "Jericho" and owned land on "Georgica Neck"; several

were buried in the old Jericho cemetery.

JOHN 6 (s. of John 5, Abraham 4) b. May 29, 1797 in E.H. d. Jan. 31, 1862 in Brooklyn; m. 1st Hannah, dau. Zachariah Hicks, June 20, 1819; she b. Amagansett 1795, d. 1826; he m. 2nd. Margaret, dau. of Judge Teunis Joraleman, May 23, 1827; she b. 1806, d. 1882; ch. Mary E. 7 b. Oct. 22, 1820, d. 1868 (who m. J. Madison Huntting Aug. 12, 1846 and had s. Teunis Dimon Huntting); Esther 7 b. Nov. 20, 1822 d. Sept. 16, 1825; Jane Joraleman 7 b. 1828, d. 1895 (who m. DR. JOHN NICHOL 8 b. June 16, 1862 in Brooklyn m. May Washbourne 1887;

he was a physician at New London, Conn.; ch. d. inf.

ISAAC 4 (s. of John 3, James 2, Thomas 1) b. 1735 d. Feb. 16, 1808, m. Eunice, dau. Joseph Foster of Southampton, who d. Aug. 4, 1809 ae 71; ch. Joseph 5 b. 1767, Isaac L. 5, David Foster 5, Rachel 5 bapt. 1784, (who m. Hedges Parsons).

JOSEPH 5 (s. of Isaac 4) bapt. Dec. 6, 1767 d. April 3, 1840 in E.H., m. 1st Mary Hedges, 1799, she d. May 14, 1820 ae 53; he m. 2nd. Hannah Hedges, 1820; ch. - *The old Canfield house moved from Apaquogue Rd. to Egypt Lane by L. Minford Humrichhouse had been moved long ago by ox-team from Sag Harbor.

- *The writer saw at the Talmage farm in Sept. 1951 a touching bit of a journal kept by Mary Talmage Dimon. The journal began the day after her wedding. Then: "April 3, Sunday, Went to church this p.m. After tea went with Dear N.—to my new home. April 4—Preparations for a party this evening."—April 13, she calls on her parents and writes down her mother's "receipts" for cup cake, cream cake, and soft gingerbread.
