LESTER

THE LESTERS have been in East Hampton only about two hundred years. This genealogy will not attempt to trace them through New England back to old England, where undoubtedly the name was spelled "Leicester" but pronounced Lester. Family tradition says they came from the north of England. According to Dr. F. A. Finch, an Andrew Lester at Gloucester, Mass. 1643 had a wife Barbara, by whom he had children: Daniel b. April 15, 1642, Andrew b. Dec. 26, 1644, Mary b. Dec. 26, 1647, and Ann b. March 24, 1651. They removed to New London, Conn., 1651, where Barbara died Feb. 2, 1654. Andrew Lester m. 2nd. Ann, and had ch.: Timothy b. July 4, 1662, Joseph b. June 15, 1664, Benjamin b. 1666. After Andrew's death, in 1669, his widow m. 2nd. May 3, 1670 Nathaniel Miller of Gloucester. Whether these Lesters and Millers had any East Hampton connection is unknown.

Lesters are mentioned on Long Island as early as 1712. Today that family is represented in Amityville, Bay Shore, Greenport, Huntington, Mattituck, Patchogue, Quogue, Smithtown, and Southampton, as well as in East Hampton Township.

It is likely that they came to East Hampton by way of Southold. The first record found of a Lester in East Hampton is 1747. In the Trustees' Records is a note: "To cash pd for transportation of men left at Mentalket" (Montauk) "said to be soldiers—Lester in Kings Lane, 17 shillings sixpence."

Maurice Lester of East Hampton has done, 1952, a monumental work in tracing his own family line, spending more than six months at it. He has followed not only the name, but the blood line on the female side, up to the present day. Due to space limitations, this book cannot go far out of the male line; but Mr. Lester's original work will be preserved complete in the Pennypacker L.I. Historical Collection at the East Hampton Free Library. It has been very helpful for related local families. It contains 974 names, all descendants of Mr. Lester's great-grandfather David Lester 1783–1865 who married Phebe Miller for his first wife, and the Widow Mary Ann Miller King for his second wife; and there are 1272 dates.

The first ancestor of all present-day Lesters in East Hampton was, as far as we know, John Lester who came from Connecticut and died here 1764. "The Widow Lester" died Dec. 19, 1779. Baptized 1764 were Elizabeth and Mary Lester; and a Mary Lester d. Oct. 1797.

The oldest Lester house in East Hampton, according to Mrs. Frederick B. Lester, is her house at Round Swamp which has never been out of the

family, and is at least 150 years old. Next oldest is Mrs. David Lester's next door, which has also been in the Lester family ever since it was built.
