MULFORD

ACCORDING TO some authorities, the Mulford family of East Hampton originated in the village of South Molton, Devonshire, England, where the name is also spelled Molford. Others are equally positive that the two brothers John and William Mulford who were among the first settlers here, were the sons of Thomas and Sarah Southcott Mulford of Maidstone in Kent. At a recent date there were Mulfords still living in both localities. The name of Mulford is found in every State in the Union. Probably not all of these are descended from the first settlers of East Hampton, though many young Mulfords left East Hampton in the 18th century and settled in different parts of New Jersey, New York, Pennsylvania and Connecticut, and their descendants scattered from there.

The two brothers came to Southampton, L.I. in 1643 from Salem, Mass. According to p. 29, Vol. I of the Southampton Town Records, John Mulford was granted two acres of land there on May 28, 1643 and on p. 55 it is recorded he sold his house in Southampton on Feb. 8, 1648, and in that or the following year was one of the nine persons who settled East Hampton; his younger brother William soon following him there. The name of John Mulford appears many times in the council minutes of Connecticut, of which Colony eastern Long Island became a part. He was commissioned a Judge in 1674. In Town affairs, keeping peace with the Indians, and representing the eastern towns in Hartford, and afterward in New York, he was prominent until his death in 1686.

When the eastern end of Long Island was first settled, a patent on certain lands was issued to the colonists direct by the reigning King of England; and under that charter the colonists instituted a government; the first Republic on American soil, it might be called. The chief magistrate was constituted the common court. A second court was constituted by a jury of twelve freeholders, and a third, the highest judiciary, was a general court, presided over by the magistrate, but in which the whole body of freeholders was constituted a jury. From 1650 to 1654, the name of John Mulford, and his only, appears as chief magistrate of this little

republic, which had full treaty power with the Indians.

A small book of great charm and humor has been written by a Mulford, and largely about the Mulfords: "An East Hampton Childhood," told by Mary Esther Mulford Miller to Abigail Fithian Halsey (E.H. Star Press, 1938; 44 pages; illustrated). It has for a cover Childe Hassam's etching: "The Heart of East Hampton" showing the John Henry Mulford house (now owned by the E.H. Historical Society) the roof of "Home, Sweet Home," the old mill, and the tower of St. Luke's Episcopal Church in the background. Commenting on the character of the

family, Mrs. Miller said: "Once a Mulford, always a Mulford,' the family saying goes. The women may marry but they stay Mulfords to the third and fourth generation, and the wives of the Mulford men, whatever their background, are soon absorbed by the Mulford clan—although my mother always said it was 'rather difficult to change a Hedges'."

*Capt. Samuel 2 was a Town officer at an early age, member of the Provincial Assembly of N.Y. from 1705 to 1720; was Capt. of Colonial Militia. He engaged in whaling and commerce, with a warehouse and pier at Northwest. He had a good deal of trouble with the Royal governor and went over his head to London in 1716. By his pleading, the duty on whale oil—unjustly levied so eastern Long Islanders thought—was removed. It was on this visit to London that he earned the nickname of "Fishhook Mulford." See sketch of his career in history section, this book; also in "Whale Off! The Story of American Shore Whaling" by Everett J. Edwards and Jeannette Edwards Rattray (Stokes, 1932). His story was, with permission, made into a play for the radio in March, 1951 on the program "Cavalcade of America." Capt. Samuel Mulford was played by Louis Calhern. It was rebroadcast later to U.S. service men abroad. Samuel Mulford's story is now incorporated in Junior High School social studies textbooks. His cane, waistcoat, and account book have been preserved by members of the family. Judge Henry P. Hedges said of him (1897): "From his father he inherited the strong reflecting mind: the stern principles and unyielding determination of the early Puritans."

**Most historians give no last name for Esther. Dr. F. A. Finch says she was dau. of Stephen and Rebecca Shaw Hand. David Mulford, who has given the matter considerable study, says it is a mystery of long standing; but refers to the book "Lineal Descendants of Susan (Mulford) Cory, Wife of Capt. James Cory" Vol. 3, Part 1, p. 49 (in the Pennypacker L.I. Collection) which says of Capt. Samuel's first wife: "His first wife was Esther Conkling. She died Nov. 24, 1717 aged 64, according to tombstone; E.H. Church records give her age at death as 'about 80.' Exact date of her marriage is not known. Indirect circumstance seems to indicate Samuel's 1st w. was a dau. of Ananias Conkling by his third wife, whom he married when she was a widow of Robert Rose. Conkling died about 1657, when daughter was about 4 years old. John Mulford with Thomas Baker and John Hand agreed on plan suggested by her oldest half-brother, Jeremiah Conkling, who was then administrator of the estate for 'her bringing up till she was eight years old.' *Col. David 4 was, like his ancestors John and Samuel, a leading citizen in E.H. Commissions appointing him to offices in the local militia, one dated 1748 and signed by Governor Clinton; and another dated 1758, signed by Lieut. Gov. James De Lancey, are still in existence. In 1775 he was appointed muster master of troops to be raised in Suffolk Co. In a list of field officers his name appears as 1st Colonel, and he reported to the Provincial Congress March 5, 1776 that his regiment consisted of 670 privates and 98 officers. He was on the march to Brooklyn at the head of his troops when the Battle of Long Island decided the fate of that part of the state and his men dispersed and went to their homes by order of the Commanding General. He went to Stonington, Conn. in Sept. 1776; his son, Major David Mulford 5th gen. also went to Conn. The widow of Col. David 4, she b. 1736, m. 2nd. Capt. William Johnson Rysam and went to live in Sag Harbor.

The "Genealogy of the Mulford Family" (71 pages) compiled 1893 by Mrs. A. E. Kitchell, says, p. 27, that Christopher, Timothy, and Esther Mulford, all children of Timothy (called "second son of Matthew") left E.H. in the latter part of the 17th century for Hanover Neck, N.J. where the two brothers bought a large tract of land extending from the Whippany River on one side and the Passaic on the other, paying 1,757 English pounds, 7 s. 6 d. for it. Mrs. Kitchell wrote that Christopher Mulford, her grandfather, married Jane Ross of Rockaway, N.J. March 21, 1776.

Mrs. Malcolm B. Lowe of Tenafly, N.J. and Quogue, L.I. traces her descent from William Mulford, son of Christopher, and his wife Catherine Campfield; their daughter Susan Emeline, b. Oct. 1, 1781 d. June 15, 1867, m. John Erwin of Jersey City, N.J. and had a daughter Susan who married John Pruden; their son in turn was Dr. William Heston Pruden, who married Margaret Van Houten and became the father of Dr. Kenneth Clyde Pruden, and of Florence Pruden who is Mrs. Lowe.

The writer finds no son Timothy for Matthew Mulford 3. There are brothers, Christopher 4, and Timothy 4 with a sister Esther 4, but they seem to be children of Timothy 3; and Christopher 4, b. 1723, rem. to N.J.; so there is some confusion here. Mulfords came and went between E.H. and N.J., from 1699.

Since this book must confine itself chiefly to East Hampton this confusion should be cleared from N.J. records. At any rate, these Mulfords were descendants of John 1 of E.H. and they built themselves, in New Jersey, substantial, picket-fenced houses exactly like those on East Hampton's Main Street.

Mrs. Edwin L. Sherrill has given the writer a copy of part of a leaflet by Stuart C. Wade, Lenox Library, N.Y. City, 1900; it traces the descent of Tripheny Mulford, daughter of Christopher 5th gen. who married Benoni Hathaway of Malapardes, N.J.; and had a daughter Phebe who married Abraham Parsons of The

Springs in 1837 and was Mrs. Sherrill's great-grandmother. Chloe Mulford, an aunt of Tripheny, had married John Parsons, and was grandmother to Abraham. The later generations are correct of course, but the early N.J. ones seem somewhat confused.
