OSBORN OR OSBORNE

THIS NAME, variously spelled, has existed more than a thousand years. In ancient Saxon England it was sometimes spelled Osbjorn; the wife of King Egbert was an Osborne. Egbert of the house of Cedric, King of Wessex, united the seven Saxon kingdoms of Britain into one kingdom under the name England in 827, A.D. Earliest record of the Osborn family appears in a will of Harjanna and Julian Osborn of Kent, bearing date of 1404. The family lived in and around Maidstone then, and is still represented there. The first Osborn in East Hampton was Thomas of Ashford in Kent who owned land in Hingham, Mass. before 1635, moved to Windsor, Conn. by 1637, and was one of the early settlers of New Haven, Conn. in 1639. Thomas came to East Hampton in 1650 to 1651. His son John 2 was one of the first settlers of Wainscott, five miles west of East Hampton village, and in the township. East Hampton was first named Maidstone because so many of its first settlers had come from that vicinity; and Wainscott was doubtless so named after a hamlet named Wainscot in England, near Rochester, and not very far from Maidstone. Mrs. George Odell (born Mary Osborn of Wainscott) visited the English Wainscot looking up her ancestors; and Ernest Clowes of Bridgehampton has located church records in that parish which give marriages of early 18th century Osbornes.

Preparation of the following genealogy (which does not attempt to carry the family far out of East Hampton Township) would have been impossible without data furnished by Osborn Shaw of Bellport, L.I., Brookhaven Town Historian and himself a descendant of East Hampton Osborns; by William E. Osborn of Mt. Vernon, N.Y.; by Raymond H. Osborn, Mrs. Ralph Frazee, Mrs. Amy Osborn Bassford, Nelson C. Osborne, Mrs. Alice Dayton LaPointe, also Dr. Frederick A. Finch's notes and Judge Hedges' genealogies have given some basic information. Miss Minnie L. Huntting, who with her brother Daniel Osborn Huntting occupies one of the few East Hampton homesteads which have never passed out of the family, has prepared the whole of one section: "Descendants of Daniel Osborn 3."

Early American Osborns were tanners; Thomas 1, trained in that trade by his father in England, was given liberty to cut trees on the common in New Haven for his tanning. In 1660 Thomas 1 deeded to his son Jeremiah his house and tanyard in New Haven. Deacon Abraham Osborn 6 (1776-1855) grandfather of the late Burnett Mulford Osborne who lived on the property now that of the Maidstone Arms, said that Thomas 1 and 2, Joseph 3 and his three sons Joseph 4, Jeremiah 4 and Thomas 4, Lewis 5 and Abraham 6, all tanners, worked for six generations at that

trade on the hill where he resided; also for generations the family and descendants of Daniel 3 and his son Deacon Daniel 4 so wrought.

A beautifully carved chest, said to have been brought from England by the first Thomas Osborne, was given to the John Howard Payne memorial house "Home, Sweet Home," by the late B. M. Osborne.

It is interesting to note that Thomas and John Osborn were promoters for East Hampton of an agreement between the offshore whaling companies of East Hampton and Southampton, in January 1667. Descendants of John 2, John M. and Oliver S. Osborn of Wainscott, were among the last of the offshore whalers here—Oliver S. Osborn headed the crew that captured the last right whale off Wainscott in 1907.

Arthur Herbert Osborn of Princeton, N.J., who has, with Dr. Donald Lines Jacobus, traced his ancestry to Ashford, Kent, England as far back as 1540, says that Thomas Osborn 1, with his brother Richard, was one of the original settlers of the Colony of New Haven in 1638 coming there from Boston under the leadership of the Rev. John Davenport with a group of thirty or forty. He says that Thomas 1 was the son of John Osborn who in turn was the son of another Thomas Osborn, both of the latter born and buried in Ashford, Kent; and that he came to this country about 1634, removing to E.H. about 1648.

THOMAS 1, bapt. April 4, 1594/5 in Ashford, County Kent, England, died in either East Hampton or New Haven between 1677, when he made his will, and 1686, when his son Thomas is called Senior. He is thought to be the son of Jeremy and Joan Wybourne Osborne (due to cousins being named Thomas, there is some doubt) and is known to be the grandson of Thomas and Wilmeth Osborne. He married Mary Goatly on Jan. 18, 1621/2 at Ashford. Ch. born in Ashford: Thomas 2, bapt. Nov. 24, 1622, d. in E.H. Sept. 25, 1712; Jeremiah 2 bapt. March 20, 1624/5, d. April 26, 1676 in New Haven, Conn.; Richard 2 bapt. July 15, 1627, d. Jan. 1628/9; John 2 bapt. July 31, 1631, d. about 1687 in Wainscott; Stephen 2 bapt. Feb. 24, 1633, d. 1698 in Elizabethtown, N.J.; Joseph 2 bapt. Dec. 4, 1636, d. in Elizabethtown, N.J. after 1707. Ch. b. in New Haven, Conn: Rebecca 2 bapt. Oct. 23, 1642 d. E.H. April 10, 1704; Increase 2 bapt. Feb. 5, 1643/4, Benjamin 2 bapt. Jan. 3, 1646, d. Feb. 27, 1721. THOMAS 2* b. Nov. 24, 1622, in Ashford, Kent, England, d. Sept. 23, 1712 in E.H.; he m. 1st Elizabeth ———, m. 2nd Mary, dau. Robert and Jane Bond of E.H.; ch. of 1st m. Thomas 3, said to have d.y. (possibly also Jonathan 3 and Bezaleel 3). Ch. of 2nd m.: Joseph 3, b. 1660 d. Oct. 2, 1743, Daniel 3 b. 1665 d. Jan. 6, 1713, Abigail 3 b. 1671, (who m. Samuel Filer 1691).

*He served the town in various civic offices.

JOSEPH 3* (son of Thomas 2, 1) b. in E.H. about 1660 d. Oct. 2, 1743. Neither Judge Hedges nor other genealogists mention any wife of Joseph 3 earlier than Mary, dau. of William and Hannah Stratton Hedges whom he m. 1704; but it seems quite likely that he married earlier. A "Mary Talmage" is mentioned in his will made April 26, 1739, proved 1746 as a wife of Joseph; in Sept. 1696 the "wife of Joseph" died; and Elizabeth, dau. of Joseph, m. Dec. 6, 1711, Thomas Baker Jr. By Mary Hedges, b. 1672, d. Aug. 2, 1752, he had ch. Joseph 4 b. Oct. 7, 1705, d. Nov. 2, 1786; Jeremiah 4 b. April 27, 1707, d. Aug. 24, 1775; Mary 4 b. Nov. 20, 1709, m. 1736 Daniel Baker Jr.; Thomas 4 b. Sept.

13, 1713, d. Dec. 27, 1753. Joseph 3 like his father, held various Town offices. Rev. Nathaniel Hunting set down in the E.H. Church Records: "2 Oct. 1743, Joseph Osborn son of Thomas Osborn, Deceased, sunk down and died in ye meeting house just after morning prayer was begun abt a quarter after 10, aged almost 83 years, he never spoke a word but expired at once." Then on August 2, 1752: "Died ye Widow Osborn, aged 81 and mother of Jeremiah, Joseph and Thomas Osborn. Six persons have died in less than Six Days. Never did East Hampton know the like. O that for holiness too yt there never were the like."

*Joseph 3 left to his son, Deacon Joseph 4, the homestead now Maidstone Arms property.

Sept. 15, 1772; Mary 5 d. Sept. 20, 1828; Lewis 5 bapt. July 20, 1748 d. Sept. 14, 1783; Phebe 5 d. Dec. 29, 1752 ae 2.

*The story is told of Deacon Joseph, a man of strong convictions and a resolute patriot, that during the Revolution, on his way to church, he was ordered by a British officer to appear forthwith, with his team and cart, at an appointed place to do service for the British army. The Deacon inquired by what authority the officer commanded him. The answer was: "By authority of the King." "What King do you serve?" asked the Deacon. "King George the Third." The Deacon replied: "My King is greater than your King. I serve King Jesus. He commands me to go to meeting and I shall go." And he marched to church. He became a refugee to Haddam, Conn. Nov. 1776 and was permitted with his s. Lewis to return to his family on L.I. Jan. 10, 1777.

JOSEPH 5 (s. of Joseph 4, 3, Thomas 2, 1) b. June 4, 1738 d. April 2, 1798 m. about 1761/2 possibly Elizabeth ———, m. 2nd Mary ——— b. 1740 d. Aug. 9, 1783; m. 3d 1774 Mary ——— probably a Mulford, who d. Nov. 7, 1793 ae 60 (Osborn Shaw, descendant of Joseph 5, thinks it possible that the first wife's name was Mary Elizabeth; there are gravestones here for two wives, both Mary; but a family Bible gives the children of "Joseph and Elizabeth Osborn".) Ch.: Joseph 6 b. Jan. 8, 1763, d. Dec. 28, 1848; Phebe 6 b. 1764, d. inf.; Temperance 6 b. 1765 who m. Deacon Joseph Hedges and rem. to East Patchogue, L.I.; Mary 6 b. 1767 who m. William Hedges of E.H., later of E. Patchogue, L.I.; Phebe 6 b. Nov. 26, 1769 m. 1793 Zephaniah Filer of Troy, N.Y. (see Filer genealogy); twins Mulford 6 and Hedges 6 b. JOSEPH 7 (s. of Joseph 6, 5, 4, etc.) b. Nov. 1, 1788; he m. and had ch. Isabelle 8, Benjamin 8.

For descendants of Joseph 5 (1738-1798) who rem. to East Patchogue, later to Bellport, L.I., see end of Osborn E.H. Town genealogy.

BURNETT MULFORD 8* b. June 12, 1856, d. Jan. 8, 1943, m. 1st Annie Phillips of Shelter Island, Jan. 3, 1889, who d. Oct. 21, 1921; he m. 2nd Lina Bucher of Zurich, Switzerland, she b. July 31, 1877. No ch.

*Mr. Osborne, with his brother, ran an inn "The Osborne House" and a livery stable, for many years. Upon his retirement it was sold and became the Maidstone Arms.

SEPTIMUS 6 (s. of Lewis 5, Deacon Joseph 4) b. June 2, 1778, d. Feb. 27, 1852; m. 1st Phebe, dau. Samuel Parsons, Oct. 2, 1805; she d. Feb. 28, 1828; he m. 2nd June 15, 1832, Fanny Bennett; she d. Sept. 3, 1881 ae 91 and is buried in a Northwest cemetery west of Powder Hill, north of highway running from Old Northwest Highway to Northwest Creek. Ch.: 1st marriage Lewis 7 b. Dec. 17, 1807, d. July 23, 1870, unmd.; Charles 7 b. July 9, 1810 d. June 19, 1890; John Gardiner 7 b. May 4, 1813, d. June 27, 1849, unmd.; Betsey Conklin 7 b. Sept. 10, 1815, d. May 7, 1860, unmd.; Samuel P. b. June 10, 1819, d. June 10, 1895, unmd.; David C. b. Aug. 23, 1821, d. June 15, 1845, unmd.

Dec. 31, 1892; a descendant of Ellis Cook who settled in Southampton about 1644. Nelson C. Osborne's grandmother on the maternal side, Hannah Cook Worthington, was also descended from this same Ellis Cook. Ch.: Phebe 8, b. Feb. 5, 1838 d. May 11, 1890, m. Jehial K. Parsons, Oct. 15, 1862 and had ch. Samuel Hedges Parsons b. March 4, 1866, d. unmd.; and Sallie Mulford Parsons b. June 11, 1873 d. unmd.; Charles W. 8 b. Aug. 25, 1839 d. Oct. 18, 1880. He m. 2nd April 14, 1897 Julia Shiebler Seidel, b. Sept. 2, 1853, d. July 15, 1918; who had dau. Maude Seidel by previous marriage.

*Charles W. Osborne was founder, with Nelson C. Osborne, and first President of the Osborne Trust Co. Bank in E.H. 1917. His brother, Joseph S. Osborne, had conducted a private banking business here. The bank became the Osborne Trust Co. later and merged with the E.H. National Bank, 1931. Charles W. 8 was for 30 years aide to Russell Sage, millionaire philanthropist; he left home at 16 and entered business in New York.

*As a young man he went West to hunt buffalo and homesteaded in Kansas. He was a Dr. of Veterinary Surgery, grad. Columbia University, practiced E.H. many years.

*Served as officer U.S.N., World War II.

JOSEPH SEPTIMUS 8* (s. of Charles 7, Septimus 6) b. Feb. 11, 1852 d. March 2, 1926, m. 1st, Jan. 15, 1885 Florence Nightingale Worthington, dau. Benjamin and Hannah Cook Worthington, she b. Jan. 12, 1861 at Bridgehampton, d. June 16, 1901; he m. 2nd Bessie M. White, April 6, 1905; no ch. by this marriage. Ch.: Charles Joseph 9 b. Aug. 13, 1886, d. June 18, 1901; Nelson Cook 9 b. March 4, 1888; Mary Gelston 9 b. Oct. 17, 1889, (who m. Oct. 19, 1918, S. Lewis Ham and had ch. Stephen Lewis, Wallace Osborne and Winifred Osborne.)

*Joseph S. Osborne 8, was for 29 years Town Clerk of E.H. He was a private banker and first in E.H. to permit depositors to draw checks against their deposits. He surveyed land and was connected with many business enterprises being one of the organizers of the Home Water Co., E.H. Electric Light Co., E.H. Lumber Co., East End Telephone Co. and others. Was an active member of a committee including J. T. Gardiner, Jonathan Baker and later George Asa Miller to compile E.H. Town Records from the earliest settlement for printing in 5 volumes. Judge Henry P. Hedges wrote introductions for the first 4 volumes, these formed part of his E.H. History, 1897. Mr. Osborne was Elder in First Presbyterian Church and Clerk of the Session for many years.

*Nelson C. Osborne has served as Supervisor, E.H. Town, and Village President (now called Mayor.) He has been President of the Osborne Trust Co., and is now its Vice-President.

*He inherited from his father the place on the corner bought of Capt. Thomas Wheeler; the last Osborne to own it was Dr. Edward Osborne 7.

JEREMIAH 6 (s. of Capt. Jeremiah 5, 4, Joseph 3,) b. at E.H. Sept. 17, 1776, grad. from Yale College and settled in Rensselaer, N.Y. where he was County Surrogate for many years. He is known to have had one s. Marcus Brutus who rem. to Illinois and d. at the age of 90.

JOHN PARSONS 6 b. July 28, 1779, m. Sarah, dau. Capt. Thomas Wickham. Ch.: Edward 7 who d. 1843, accidentally shot while hunting at Montauk; Isaac W. 7, Robert F. 7 who m. Juliet Mulford; Mary 7 who d. unmd.

*Samuel 6 lived at the corner of Woods Lane and Main Street, opposite "Pudding Hill." His son, Dr. Edward Osborne 7 inherited the place; he practiced medicine here for many years and d.s.p.

*Three Osborn brothers—Abraham, Jacob and Conklin, married three sisters—Phebe, Charity and Abigail, daughters of Stephen Hedges of Sagg. Jacob 6 and Conklin 6 moved to Blenheim Ridge (South Gilboa) N.Y. in the Catskills, where they raised families; some of their descendants have returned to E.H. Letters written to Abraham and Phebe Osborn, and to Jared and Ruth Hedges (shortly after leaving E.H.) in 1809, 1816 and 1817 by Abigail Hedges Osborn are kept by J. Howard Hand of Wainscott.

It is likely that the name "Pudding Hill," applied since Revolutionary times to the place at the right-hand corner of Woods Lane and Main Street as one enters from the west, concerns the family of Joseph 5. One of his wives must have been heroine of the incident put into verse years ago by a local ballad writer and set to music recently by Miss Louise Mulford of Amagansett. The story goes that the mistress of the house, one day during the British occupation of L.I. was busy

boiling a berry pudding for noonday dinner (huckleberry or Montauk blackberry duff), when she was surprised by foraging British soldiers. Rather than feed the enemy, she threw the boiling-hot kettle, pudding and all, down the sandy hill, to the chagrin of the hungry invaders. It was only a few years ago that a handful of British uniform buttons was upturned by gardening operations on Pudding Hill. The place is owned today by John R. Peddy.

Nathaniel Conklin Barnes.)

*Cornelius 5 served during the American Revolution as a private in Suffolk County 1st Regiment of Minute Men. He lived at Jericho, E.H.

CORNELIUS 6 (s. of Cornelius 5, Thomas 4, Joseph 3) b. at Jericho, E.H. Oct. 26, 1791, m. and settled in Monroe Co., N.Y.; ch. Robert 7, Reuben 7.

SONS OF THOMAS OSBORN 1 who removed or disappeared, early in E.H. History:

JEREMIAH 2 b. in Ashford, Kent, England, March 20, 1624/5, d. in New Haven, Conn. April 26, 1676; he m. Mary ——— who d. in New Haven 1695. There is no record that he actually lived in E.H., but a Jeremiah Osborn was witness, in 1667, to a whaling agreement signed by his brothers Thomas 2 and John 2 in E.H. No other Jeremiah would have been the right age.

STEPHEN 2 b. 1636, d. in Elizabethtown, N.J., m. Sarah Stanborough of Southampton, N.Y. Whether he left ch. in E.H. or not, we do not know; a s. Stephen was born in E.H. to Stephen Osborn Jr. in 1736.

JOSEPH 2 b. in New Haven, Conn. about 1642, d. in Elizabethtown, N.J. after 1707; m. Priscilla Rogers of Newark, N.J. An entry in church records, E.H. says: 1705—Joseph Osborn married the Widow Hossington. Another entry says that she died in 1728. Her dates do not agree with any other Joseph Osborn found.

BENJAMIN 2 b. 1647 in New Haven, Conn., d. in East Hampton Feb. 27, 1721/2 (or May, 1718 according to W. Hedges) ch. Benjamin 3 (In 1677 Thomas 1 conveyed all his lands in E.H. to Benjamin 2).

BENJAMIN 3, m. probably Elizabeth Hicks, Nov. 1, 1716; and later rem. to "East Jersie." Ch., bapt. E.H., Bethiah 4, Oct. 8, 1722; Samuel 4, May 22, 1720; Sylvanus 4 Aug. 21, 1726; John 4 March 24, 1728.

CHILDREN of Thomas Osborn 2 who are not usually given in genealogies may have been Jonathan and Bezaleel. Osborn Shaw thinks so. At any rate, there were Osborns here bearing those names at dates when they could have been sons of Thomas 2; although Judge Henry P. Hedges was inclined to think they were, together with another Joseph, sons of a wealthy Boston merchant, William Osborn. William Osborn 1 was in Salem 1630, in Dorchester 1639, at Harvard College 1661; he had a s. Recompence b. in Dorchester 1644, at Braintree, Mass. had Hannah b. Aug. 24, 1646, Bezaleel May 8, 1650, and in Boston had Joseph b. April 6, 1652 and Jonathan b. Nov. 16, 1656. He d. 1662. His widow married John Mulford of E.H. (Widow Friedeswiede Osborn). Recompence 2 graduated from Harvard and later taught school in New Haven, then went to E.H. and after 1665 disappears, probably died here; Jonathan went to Cape May, N.J. where he and his brother Joseph owned a house together in 1690. Joseph is probably the "Joseph Sr." who d. in 1741 in E.H. aged about 90.

As for Bezaleel, his "nuncupative" (oral) will recorded in the Suffolk County Clerk's office at Riverhead, L.I., gives these facts: His w. was Elizabeth Howell, sister of Arthur Howell of Southampton; he was brother of Joseph and Jonathan Osborn of E.H. He died at the home of his brother Joseph in E.H. in 1686; the will mentions no children, although he may have had a dau. who m. Ralph Dayton. East Hampton Town Records mention Bezaleel and his "share of whale," 1677. Brookhaven Town Records, under date Sept. 8, 1679, show that Bezaleel Osborn of E.H. gives 50 acres of upland and 15 acres of meadow in Brookhaven to Ralph Dayton. The Daytons, Osborns, and Bakers all came from the same part of Kent. Tradition says that the grave of Bezaleel Osborn in South End Burying Ground, was marked by red cedar posts bearing the initials B.O.

In support of the theory that William Osborn of Boston left descendants here (not mentioned in other sections of this genealogy) there are some otherwise unlocated Osborns, named William—a name which does not occur frequently in

the E.H. family. A William who m. Sarah ——— d. Jan. 16, 1774 ae 87; a William Jr. m. Elizabeth Payne on Dec. 3, 1713; he d. in Wainscott, 1743; she d. 1744 ae 53. Joanna dau. William bapt. 1719, m. Elisha Mulford Dec. 1, 1735 and d. 1774.

THE WAINSCOTT OSBORNS OR OSBORNES

ON AUG. 2, 1653 Goodman Osborne was ordered to begin driving the Dry Herd to Wainscott every morning. Wainscott land was allotted to John Osborne on June ye 8th 1668. Tradition says he was the first settler in Wainscott. In records of June 13, 1670 he was given consideration, on account of living remote from the Town, to grind at the mill on the third day of the week from ten o'clock to twelve.

The early Osborns or Osbornes of Wainscott were tanners, like their relatives in East Hampton village and back in Kent. The remains of a tan vat were found in 1904 while a cellar was being dug where John Osborne settled. Tradition credits John 1 with great physical strength, courage and hardihood; much shrewdness and a commanding personality.

Osborns still live in Wainscott on land that has never been out of the family.

The will refers to James Hand Jr. as "son" which would imply that one of Josiah Osborn's daughters married him; but Hand records do not show this marriage. The will is headed: James De Lancey Esq. His Majesty's Lt. Governor and Commander in Chief in the Province of New York, 10 December, 1754. The will of Josiah Osborn—Executors Daniel Leek and my son James Hand Jr. Quoting, in part: My wife shall have which room in my house her life time to improve—I give my son Jedediah Osborn all my right in the Windmill—my daughter Sarah Osborn and to heirs of her body lawfully begotten 2 acres of land of my home lot which is convenient to seat a house on. To my son Jonathan Osborn my last loom and all my loom tackling and ten Lbs. of York money when he shall arrive at the age of 21 years. I order that my red Cow should not be sold but be kept for my wife and she shall have the best bed and furniture. I order that my executors shall fell my woodland and none of my home Lott except there is a necessity. I give my daughter Zerviah Osborn 5£ York money. Witnessed John Hand, Jr., George Strong, Job Pierson, before Maltby Gelston.

R. show Jedediah Osborn Jr. shot to death, aged 21, Nov. 30, 1772). A daughter of Jedediah's was bapt. Dec. 17, 1772; and a s. Josiah was bapt. 1777; these are more likely to have been ch. of the Jedediah Jr. (6) who was shot, by the accidental discharge of his gun. A monument to him was erected by Col. Gardiner, Capt. Mulford, Lieut. Dayton and their soldiers.

*Jonathan 5 was a private in Capt. Hallock's Militia Co. of Bridgehampton in the Revolution, took part in the battles of Long Island and Trenton.

He inherited his father's "loom and loom tackling."

*Morgan Topping of Wainscott says: Capt. Jonathan Osborn was a famous whaleman, probably first native of E.H. to go deepsea whaling. A 1797 log is still extant. He was very smart, owned a good deal of land around Wainscott. None of his descendants live here now. One son was lost at sea; another moved to Staten Island and died. Capt. Jonathan was a very powerful man. Carting rye straw one day, he had a bag of rye grain in the wagon—a two-bushel bag weighing 100 pounds; he picked it up on a fork and tossed it onto the haymow.

He was also a very determined man. A Cooper owned the ship Union, of which Capt. Jonathan was master. She was ready to go, on one occasion, anchored off Hedges Banks, Northwest (to reach it, you go by Stephen Hand's Path but don't turn into the Hand's Creek Road, but go straight to shore.) Capt. Osborn was busy with his farm work. Mr. Cooper said "She is ready to sail." Capt. Osborn replied that he had the ship's papers in his pocket, and they would sail when he got ready.

One of Capt. Jonathan's descendants, Henry L. Osborn, was a very religious man, with strong faith in prayer. When a neighbor was sick he prayed earnestly, and the man recovered. This occurred twice. This neighbor later became very troublesome, and when sickness overtook him a third time, Mr. Osborn said "I told the Lord that twice he had recovered because of my prayers, but now we have been afflicted long enough. I said 'Now, Lord, do as you please!'"

AMAGANSETT OSBORNS

There were Osborns in Amagansett for a hundred years, but the name has died out there. The last Amagansett Osborn of whom we have any record was Mrs. Mary Laura Terry who d. in Sag Harbor Dec. 27, 1894, ae 67. Her father was Jacob Osborn of Amagansett; her mother was Maria Homan of Middle Island, L.I. Dr. Frederick Finch says that the place now owned by Mrs. Maud Rackett Bodine was once a Jacob

Osborn place. "Uncle Ben" Hedges, Mrs. Bodine's great-great-grandfather, bought it when he came "off" Montauk, in 1832.

It is not absolutely certain that the first Amagansett Osborn was the son of Daniel 3 and Elizabeth Osborn of E.H., b. 1700, who, according to Hedges' History, d.s.p. But William H. Osborn of Mt. Vernon, N.Y. in his extensive Osborn family research puts him in that family; and church records do not show his early death. "Thomas of Amagansett" in the records, d. Nov. 18, 1753, ae about 50; "Thomas of Town" (Thomas 4, s. of Joseph 3) b. 1713, d. Dec. 27, 1753, ae 40. Daniel 3 of E.H. had a posthumous child 1713 by his wife Elizabeth; according to Rev. Nathaniel Huntington's records, this child was bapt. Daniel; and there was already a Daniel 4, which adds to the confusion. But Thomas of Amagansett must have been born by 1700, for he married 1720 and had a child in 1721. This is the way the Amagansett line ran, then:

PATCHOGUE AND BELLPORT OSBORNS

Space will not allow a complete record of Osborns who moved from E.H. to points further west on Long Island. There are Osborns in East Moriches. Osborn Shaw, Brookhaven Town Historian, and his daughter Ann are the only surviving descendants in Bellport and possibly in the whole Town of Brookhaven of Charles Osborn, 6th generation, who went to Bellport from E.H. and New York City. These were the "Pudding Hill" Osborns.

JOSEPH 6 (s. of Joseph 5, 4, etc.) b. in E.H. Jan. 8, 1763, d. Dec. 28, 1843, m. Mary (Polly), who d. 1831 ae 75; he rem. to Pennsylvania but ret. to Patchogue, L.I. after his wife's death. Ch.: Joseph 7 b. 1798, d. 1869; Catherine 7, Mary 7. What became of the girls is not known. They were sent to school in Newport and their tuition and board were paid by their uncle, Charles Osborn 6; Osborn Shaw has the receipts, dated from 1804 to 1818.

HEDGES 6 (s. of Joseph 5, etc.) b. E.H. Feb. 21, 1772, d. April 26, 1846, buried

E. Patchogue, later Bellport; ch. Mulford 7 b. 1806, d. 1884; Temperance 7 b. 1801, d. 1859, Elizabeth 7 b. 1808, d. 1888.

CHARLES 6 (s. of Joseph 5, 4, 3, Thomas 2, 1) b. E.H. 1776, d. at Bellport, L.I., Sept. 14, 1846; m. 1st Eliza ——— who d. 1803 ae 18; m. 2nd in N.Y. City, 1805, Charlotte Whytlaw. Charles 6 was educated in Clinton Academy, and in 1792 went to N.Y. and became a leading hardware and ship's chandlery merchant at 33-34 Fulton St. In 1827 he bought 100 acres at Bellport and retired there to engage in farming. He was one of the founders of Bellport. Ch. by 1st m. Catherine 7 b. May 10, 1801, d. some time after Feb. 3, 1811, when she wrought a sampler owned by Osborn Shaw; it being the sole record of her existence; Charles Joseph 7 b. Jan. 25, 1803, d. Feb. 25, 1891. Ch. by 2nd m.: Thomas Whytlaw 7 b. Feb. 22, 1907, d. unmd. June 21, 1852; James 7 b. Sept. 26, 1808, d. unmd. Sept. 11, 1835; Henry Fleet 7 b. Oct. 18, 1810, d. Dec. 1, 1873; John 7 b. Nov. 12, 1812, d. March 26, 1842; Albert 7 b. Dec. 12, 1814; Edward 7 b. July 26, 1817, d. Jan. 24, 1873; Monroe 7 b. April 25, 1821, d. unmd. Jan. 10, 1842.

JOSEPH 7 (s. of Joseph 6, 5, 4, 3) b. Aug. 18, 1798, d. Brooklyn, N.Y. April 2, 1869; m. at Patchogue, L.I. 1826, Jerusha dau. of Joseph Hedges 5, his cousin. Joseph took over part of his uncle Charles Osborn's business in Fulton St., N.Y. with John Swan; ch. Isabella Graham 8 b. 1828, d. unmd. Patchogue, 1912; Mary Elizabeth 8 b. 1834, d.y.; Joseph 8 b. 1837, d.y.; Maria 8 b. 1840 d.y.; Benjamin Franklin 8 b. Oct. 1843, d. 1877.

HENRY FLEET 7 (s. of Charles 6, Joseph 5 etc.) b. in N.Y. City Oct. 15, 1810, d. Dec. 1, 1873; m. Oct. 28, 1849, Eliza, dau. of Isaac Ruland of Patchogue, she b. Feb. 10, 1813, d. Bellport, Aug. 26, 1899. Henry Fleet 7 was a gentleman-farmer; educated in N.Y. and Clinton Academy, E.H.; in 1855 he made a trip to Europe in a sailing vessel, taking along for company Dr. James Rice of Patchogue. Ch.: Annie Whytlaw 8 b. Dec. 13, 1850, d. Jan. 5, 1933; m. Nov. 21, 1877 Joseph Merritt Shaw Jr., s. of Joseph and Caroline Gerard Shaw of Bellport, who d. June 24, 1933.

OSBORN SHAW, only surviving ch. of Joseph M. and Annie Whytlaw Osborn Shaw, was b. Sept. 5, 1882, lives in Bellport; m. June 15, 1927 Mable Ayres Reddall, dau. John W. and Mary Smith Reddall of Brooklyn and Brookhaven; she b. June 20, 1887, d. Nov. 23, 1939. Their only child is Ann, b. Oct. 6, 1928. Osborn Shaw is a veteran of World War I, in France; editor of the five volumes of Brookhaven Town Records, and compiler of a genealogy of the Osborn family in Brookhaven and of several other Brookhaven families in mss. form. He has been official Historian of the Town of Brookhaven since 1936.
