## TALMAGE

THE FAMILY name has been written in a dozen ways, including Talmadge, Tallmadge, Tallmage, Tolmash, Talmash, and Tollemache; these spellings being used interchangeably; but it is always pronounced just as we pronounce it in East Hampton.

The Talmages are one of the oldest families in English history, dating back to Saxon times when Toelmag, a Saxon lord of the sixth century,

owned land in Oxfordshire and lived in Bentley Hall, Suffolk.

"Before the Normans into England came,

Bentley was my manor and Talmash was my name."

This distich is said to have been inscribed over the ancient gateway at Bentley Hall. Bentley lies on the banks of the River Orwell. At a recent date the name was found to be represented by two titles in the Peerage of England, that of the Earls of Dysart, who have spelled the name Talmash; and that of Lord Tollemache of Helmingham Hall, not far from Bentley.

A footnote in one of two priceless bound manuscript volumes written by Robert Swartwout Talmage of New York (a descendant of Thomas Talmage the Recorder of East Hampton) says: Gen. James Grant Wilson in an article in the "New Jersey Historical Society Proceedings" (1896) writes: "I was lately the guest of an Englishman whose ancestors had lived on the same spot for over a thousand years—Lord Tollemache occupies an ancient castle (Helmingham) surrounded by a double moat where drawbridges are raised as they were in the days of Queen Elizabeth—when I asked him if his ancestors came over with William the Conqueror, the proud old patrician of four score replied, 'No, my family was seated here a hundred years before the bastard was born.'"

The above-mentioned books have been lent by their author for use in compiling this East Hampton Talmage genealogy. They are titled: "Family Records of the Talmage Family in England and Its Settlements in America," and "The Talmages of Somerset County, N.J. and New York City." The books are illustrated with photographs and photostated documents.

The name of Roberti de Toelmag is found in Domesday Book; he is located in Suffolk in 1068. The name Talmage is found at Stoke Talmage in Oxfordshire in 1135, in Norfolk in 1200, and in Hampshire in the 14th century. The seat of the family in Hampshire was at Newton Stacey; it was from there that the first American Talmages came.

Different American writers on this family have made contradictory statements; it has been a difficult line to untangle, in spite of the mass of material. Some of the source material for this book is from a 373-page

book published 1909 by Arthur W. Talmadge of the New Jersey branch of the family; also from a 50-page genealogy compiled 1901 by the late Sineus C. M. Talmage of East Hampton; from a Talmage family tree drawn 1930 by the late Charles O. Gould of East Hampton; from Talmage material furnished by Mrs. Adelaide Mershon Purcell of Montclair, N.J. and East Hampton; from a family Bible with enclosed records lent by Miss Marian Talmage and her brother Charles De Witt Talmage of East Hampton; and from research by Mrs. Everett J. Edwards of East Hampton. When all these had been assembled and put in order, the result was taken to Robert Swartwout Talmage of New York who has made family history a lifelong study doing research in this country and in England. He has very kindly checked this genealogy of the East Hampton Talmages and has furnished valuable new material, so that it may be considered authoritative. Mr. Talmage returned from one of countless visits to England in September, 1952; he has visited old Talmage properties, he has met distantly related English Talmages and carried on a correspondence with them for years.

The Talmage family of Hampshire is traced by Robert S. Talmage (his first book, p. 37) from Sir William Talmach, brother of Sir Hugh of County Suffolk, and probably son of Sir Peter Talmach of Oxfordshire, born 1200 or earlier, to William Talmage of Barton Stacey, whose will was made 1581; he was father of John Talmage of nearby Newton Stacey who died 1640, and of Thomas, Puritan ancestor of the American Talmages.

In All Saints Church, Hawsted, Suffolk, is an effigy of a knight in full armor, having both arms and legs crossed (the Crusader), which is thought to be that of Sir William Talmash; the Talmash arms are in stained glass windows there. In 1270 Edward 1st, known as Edward Plantagenet, son of Henry III, formed the Seventh Crusade; he was proclaimed King during this expedition. On the way home to England Gascony was reduced (1272) and Sir William Talmach was killed in that battle. His wife, the Lady Cecilia, doubtless had the Gothic tomb placed in the church at Hawsted, then called Talmash Manor.\*

This brings up the question of the Talmage coat of arms. No coats of arms belonging to any East Hampton family will be pictured in this book; that is too controversial a subject and calls for very special knowledge. However, since it has been stated many times that the Gould family today (1952) possesses the parchment coat of arms brought over by Thomas Talmage 1 from England, something should be said on that subject. This coat of arms differs completely from that accepted by Robert S. Talmage as the correct one from the Talmages in England. His books show and describe the English coat of arms with its fretted cross; he has family heirlooms bearing these arms and the motto: "I Trust and I Con-

quer." In 1909, Arthur White Talmage in his genealogy accepted the East Hampton arms, although mentioning the arms borne in England and the above motto. Today, Robert S. Talmage considers that the parchment now owned by J. Arter Gould of East Hampton and handed down from Phebe, daughter of Onesimus Talmage who married Severus Gould and thought for generations to be the Talmage coat of arms, to be actually that of the Gould family. The Arthur White Talmage genealogy considers the East Hampton parchment to be of early origin, originating possibly in Cornwall. Since Onesimus 3 was a younger brother of Nathaniel 3, and the latter had sons, it seems probable that a family coat of arms would have been handed down in Nathaniel's family.

Records have established that Thomas Talmage, his wife, three sons and a daughter, left England for New England in "The Plough," a ship of 60 tons. In London, during the reign of Charles I, a small body of dissenters called "The Husbandmen" or the "Company of the Plough" had been formed; these names meaning the religious field rather than earth-culture, most of the members being merchants or artisans rather than tillers of the soil. Their leader was Stephen Bachiler who in 1622 was living and preaching the Puritan faith at Newton Stacey. It was decided to send a band of settlers into New England to propagate their ideas. Bachiler was a friend of John Winthrop, who became Governor of Massachusetts. The Talmages were in this group, and were settled in Lynn, near Boston, by the spring of 1630. There Thomas 1 was made a freeman in 1634 and granted 200 acres, becoming one of the largest landholders in the town.

The three sons who came over with Thomas Talmage 1 were William, Thomas and Robert; the daughter was Jane, who married Richard Walker and died before 1641. Other children were Simon, who stayed in England, and Christian, a daughter, who m. 1st William Warham of Oakley, near Barton Stacey, and m. 2nd Edward Belcher of Guilsborough, Northamptonshire, ancestor of royal Governor Jonathan Belcher in Massachusetts and New Jersey; she never came to America. William 2 settled in Boston and died there. He married twice, and left two daughters by his second wife (see p. 22. Talmage genealogy by Arthur W. Talmage). Thomas 1 removed from Lynn to Southampton, L.I. in 1642. In 1649 he went to East Hampton where his son Thomas 2 had preceded him. Robert, youngest of the three sons who crossed the Atlantic, went to Southampton with his father but the next year, 1643, he removed to New Haven, Conn. where he died in 1662, leaving a considerable estate in what is now the business center of the city and of great value. From Robert 2 all of the Connecticut Tallmadges (that is the way they prefer to spell it) are descended. This branch has produced men of distinction in public life and in their country's service, among them Col. Benjamin Tallmadge\* of Revolutionary fame who was a friend of George \*See "General Washington's Spies, On Long Island and in New York" by Morton Pennypacker, publ. 1939 by the L.I. Washington, also many Judges of the higher courts, senators, and congressmen.

Thomas 2, ancestor of the East Hampton and New Jersey Talmages, has also had many distinguished descendants, of whom one of the most widely known was the Rev. Dr. Thomas De Witt Talmage, the famous Brooklyn preacher, who delivered his first sermon in the little old Town House which is still standing in East Hampton. For many years Dr. Talmage had a summer home here; he and his family built a series of summer residences on what came to be known as "Divinity Hill." He often occupied the pulpit of the Presbyterian Church here during the later years of his life. He made a pilgrimage to England, looking up his ancestors (of which much less was known in his time than today) and visited Helmingham Hall. He left notes on that visit; some of these have been lent the writer by his grandniece, Mrs. Purcell.

THOMAS TALMAGE 1 b. abt. 1595 at Barton Stacey, Hampshire, England; d. in E.H. 1653. His wife's name we do not know; she outlived him.\* Ch. Simon (who remained in England), William 2, Christian 2 (who remained in England), Jane or Joan 2, (who never came to E.H.), Thomas 2, Robert 2, perhaps Davis 2 or David 2 b. 1630, who is mentioned in E.H. Town Records as being granted land 1655.

\*E.H. Town Records, Vol. I, p. 54 mention the Widow Talmage Dec. 9, 1653; a share of whale in controversy between the Widow Talmage and another is to be divided "even as the lott is."

CAPTAIN THOMAS 2 b. in England abt. 1617, d. in E.H. 1691, was one of the nine original settlers of Maidstone, now E.H., and a man of great prominence in the early history of the town. He was the first Recorder or Town Clerk, chosen 1650. His original Book of Records is still in a fine state of preservation. In "Chronicles of East Hampton" (1871) David Gardiner says of him: "he must have had a good education for that period, when in the mother country the teaching of grammar was held by agrarians—'a corrupting of the youth of the realm." In 1655 Thomas Talmage was elected Lieutenant and later Captain of the Train Band (militia). Thompson's History of L.I. says: "Thomas Talmage was a man of superior education, polished manners, and great wit. During the reign of George I, he, with his wife, visited England, where they were entertained by the sovereign, spending a fortnight at Windsor." In 1690, Thomas Talmage's property assessment exceeded all others in the settlement. He m. Elizabeth, dau. John and Joan Bancroft of Lynn, probably before leaving Massachusetts; she d. May 20, 1704. In Howell's History of Southampton is an entry: "The widow Bancroft of Lynn gives unto Thomas Talmage and John Stratton this lot of land to keep, improve and possess, 1664." Robert S. Talmage says that the Talmage and Stratton families were closely associated, and that Thomas Talmage and John Stratton married sisters. (The Widow Bancroft must have come to E.H., for she was fined here for slanderous gossip.) Ch.: Nathaniel 3 b. 1643/4 d. Aug. 3, 1716; Shubael 3\* b. 1656 d. Oct. 1, 1742, unmd.; Onesimus 3 b. 1662, John 3 who was drowned 1670 (see p. 328, Vol. I. E.H. Town Records), Naomi 3, Mary 3 (who m. Thomas Hand and rem. to N.J.), Hannah 3\*\* or Phebe 3 (who m. Edward Jones, Jr. and had dau, Elizabeth who m. John Wick; she and her Wick ch. were taken to live with the E.H. grandparents and dau. Elizabeth m. 1752 Thomas Talmage 5th gen. of the N.J. branch); Sarah 3 (who m. Thomas Bee). Thomas Talmage the Recorder and

- his descendants lived and owned land at Georgica which is still (1952) in the family; they lived until about 1830 on the property now owned by Howard Morris, overlooking Town Pond on the West side of Main Street. "The Mansion" was torn down and Mrs. Sarah Gardiner Tyler, daughter-in-law of President John Tyler, owned the present house for many years.
- \*A book of Bible annotations printed London 1688, inscribed "Shubael Talmage his book, July the 31 day in the year 1717. Price 3 pounds, 15 shillings" has been handed down in the Parsons family.
- \*\*This note regarding Hannah 3's marriage is from Robert S. Talmage; the writer of this genealogy finds, under Jones of E.H., that: Edward Jones 3 m. 1696 Phebe, dau. Thomas 2 and Elizabeth Talmage, she b. 1680 d. Nov. 6, 1740; they had 9 ch. of whom one was Elizabeth; no date given. Probably Hannah is correct. That name is mentioned in her father's Will.
- DAVIS OR DAVID 2\* (perhaps s. of Thomas 1) b. 1630 d. May, 1708, is credited by Arthur W. Talmadge's Genealogy (p. 28) with the following ch.: Enos 3 b. 1660, Stephen 3 b. 1661 d. 1742 at Bridgehampton.
- \*Robert S. Talmage does not credit Thomas 1 with a son Davis or David.
- CAPT. NATHANIEL 3\* (s. of Thomas 2, 1) b. in Southampton, L.I. 1643/4, d. in E.H. Aug. 3, 1716, m. Rebecca—she b. 1658 d. 1743, probably a 2nd w. ch. Thomas 4\* b. 1676, John 4 b. 1678 d. Nov. 2, 1764, Elizabeth Joan 4 b. abt. 1685, d. unmd.; Martha 4 (who m. Samuel Russell 1708) Enos 4 b. 1690, Daniel 4 b. 1693, Rebecca 4 (who m. John Conkling who came from Southold), Naomi 4 b. 1701 (who m. Elisha Halsey of Southampton, 1730).
- \*Nathaniel 3 inherited the original home lot on Main Street E.H., which was in turn inherited by his son Thomas 4, Dr. Finch's research gives Thomas 4 as the oldest son. Robert S. Talmage considers the oldest to have been John; probably because the Will of Nathaniel 3 mentions John first; John inherits land in Bridgehampton, which Mr. Talmage thinks may have come from Nathaniel's first marriage. Rebecca, probably 2nd. wife, was an Osborne, Mr. Talmage thinks. The writer can find no one of that name in the Osborn-Osborne genealogy who seems likely to have married Nathaniel 3. Nathaniel served as Constable 1687, and as Town Trustee 1689-1705; he bought land in Wainscott 1677.
- CAPT. ONESIMUS 3\* (s. of Thomas 2) b. 1662 d. Feb. 1, 1723, m. Rebecca, dau. Capt. John Wheeler; ch. Thomas 4 who d. Nov. 13, 1722 ae 20, Phebe 4 (who m. Severus Gould Nov. 11, 1719 and inherited the home lot and house adjoining John Hedges'—now on James Lane) Sarah 4 (who m. 1724 Nathaniel Farnum of Chillingworth, Conn.), Mary 4, probably unmd.
- \*His will is given in the Talmage genealogy by Arthur White Talmadge, p. 34. He was an officer in the Army in an expedition against Canada, 1711 (see Annual Report, N.Y. State Historian, Col. Series Vol. II).
- THOMAS 4\* (s. of Nathaniel 3, Thomas 2, 1) b. 1676 d. Oct. 24, 1764, m. Mary, dau. Stephen Bailey of Southold, L.I. (sister of the wife of Joshua Hempstead) Nov. 10, 1706; ch. Mary 5 bapt. 1707 (who m. Jonathan Baker, Jr. Nov. 23, 1732 and had s. Thomas Baker, who had seven daughters); Temperance 5 bapt. 1710 (who m. Sueton or Stephen Grant), Abigail 5, bapt. 1712 d. 1713; Thomas 5 bapt. 1722, d.y.; Thomas 5 again bapt. 1730.
- \*Thomas 4 was elected Constable 1709, and Town Trustee 1730, 1732, 1742, 1745.
- JOHN 4\* (s. of Nathaniel 3) b. 1678 d. Nov. 2, 1764, lived at Wainscott; he m. 1st Experience, dau. John Miller, Dec. 25, 1702; she b. 1685, d. Aug. 30, 1723;

Feb. 17, 1717; he m. 2nd Dec. 14, 1721 Katherine, dau. of Nathaniel Baker, widow of Benjamin Townsend who had d. 1716 in Conn.; ch. Katherine 5 bapt. 1722 (she m. 1744 John, s. of Thomas and Abigail Parsons Davis), Katherine, "relict of Enos Talmage," d. May 12, 1752 ae 66; but it is on record that the Widow Kate Talmage m. 3d. 1737, Thomas Mulford.

## THE NEW JERSEY TALMAGES

Who have, in many cases, continued to be closely associated with East Hampton. Rev. Dr. T. De Witt Talmage, 8th gen. occupied a summer home and the family had considerable real estate in East Hampton up to the 1930's. Last of this branch to summer here were Rockwell Talmage, 10th gen., who moved from here to Southport, Conn. and John Frelinghuysen Talmage, ninth gen., who with his wife, Louise Ditmas, and their family occupied "Tollemache House" on Ocean Avenue until the late 1930's.

Robert Swartwout Talmage, 10th gen., says that his mother was troubled with rheumatism and the doctor advised her to go to East Hampton and take sea baths as a cure; so the spring before he was born she stayed at Mr. and Mrs. Sylvanus Parsons' boarding house (home of Dr. and Mrs. David Edwards, 1952). His father, John Fowler Talmage, bought a house here in 1878. When Mr. Talmage was sixteen he was already interested in Talmage family genealogy. At about that time James M. B. Dwight, brother of President Dwight of Yale College, who had married a daughter of Major Charles B. Tallmadge of New Haven, spent a summer in East Hampton. Both Mr. and Mrs. Dwight were keenly interested in early Talmage history. They talked with Rev. Dr. T. De Witt Talmage, during the bathing hour at the beach. He said he knew little about Talmage genealogy, but pointed up the beach to young Robert, sitting under a beach umbrella with his mother, and said "Mrs. Talmage's boy can tell you more than I can." Local records were searched; later Mr. and Mrs. Dwight spent several years in England and had abstracts made of family wills. At the death of Mr. Dwight, all of his records passed on to Robert S. Talmage. Mr. Talmage has inherited 17th century furniture from East Hampton, and other family heirlooms, some of which he has placed in the Museum of the City of New York, and some of which furnished a Talmage Memorial Room (1926) in the Lefferts Homestead, Prospect Park, Brooklyn, headquarters of Colonial and Revolutionary societies.

DANIEL TALMAGE 4 (s. of Nathaniel 3, Thomas 2, 1) b. in E.H. 1693, d. in Elizabethtown, N.J. 1725. Elizabethtown's first settlers came largely from three English towns on the east end of Long Island—Southold, Southampton, and East Hampton. Daniel 4 was ancestor to the N.J. branch of the family. A Talmage family chart drawn by Col. Daniel Talmage in 1846, owned 1952 by his grandson Robert S. Talmage, gives the date of the arrival in N.J. of Daniel Talmage 4 as 1717, shortly after his father's death. He married Hannah, daughter of Thomas Morris of Elizabethtown, and granddaughter of John Meeker. Ch. Hannah 5 (who m. John Ross), Thomas 5 b. 1722, Daniel 5 who d.y., Enos 5.

CAPT. THOMAS 5\* (s. of Daniel 4, Nathaniel 3) b. March 1, 1722 at Elizabethtown, N.J. m. 1st Hannah Norris and had ch. Daniel 6 b. 1745, John 6 b. 1747, Enos 6 b. 1750 d. 1751; also daughters. He m. 2nd. Elizabeth Wick of E.H. Sept. 20, 1752; she b. 1730 d. 1785; and had s. Thomas 6 b. 1755, and six daughters; he m. 3d., no ch. He died at Basking Ridge, N.J. Feb. 25, 1790.

\*He was a builder and surveyor and in 1773 the first suspension bridge in N.J., spanning the Raritan River, was built by him.

DANIEL 6 (s. of Thomas 5, Daniel 4) b. 1745, killed in the battle of Lackawaxen in the Revolution, 1779; he m. Lois Allen; sons Thomas 7, Aaron 7. JOHN 6 (s. of Thomas 5 etc.) b. 1747, at Elizabethtown, N.J., d. at Basking

Ridge, N.J., 1777; he m. and left 3 ch.

MAJOR THOMAS 6\* (s. of Thomas 5, Daniel 4) b. at Basking Ridge, N.J. Oct. 24, 1755, d. Oct. 2, 1834 at Somerville, N.J., m. 1775 Mary, dau. of Capt. Goyn Mc Coy, she b. 1758 d. 1832; her ancestors were Scottish people shipwrecked on the Caledonia off Perth Amboy, N.J. There were 12 ch.: Susanna 7 b. 1776, Thomas Goyn (Gavin) 7 b. 1778, Daniel 7 b. 1780, David 7 b. 1783, Rev. Jehial 7 b. 1785, Elizabeth 7 b. 1788, Sarah 7 b. 1790, Thomas 7 b. 1794, Mary 7 b. 1796, Rev. Dr. Samuel Kennedy 7 b. 1798, Phebe 7 b. 1801, Dr. John 7 b. 1804.

\*Great alarm was felt in the spring of 1778 when Tories and Indians menaced the people at Minisink, N.J. Thomas Talmage made a famous ride spreading the alarm over the countryside, while ill with typhus (or typhoid). He enlisted in Capt. Ten Eyck's company and served in many of the N.J. engagements, winning promotion. He built Mont Verd, near Somerville and managed his own plantation of several hundred acres. He built the County Court Houses of both Somerset and Middlesex Counties; and built Somerville Academy. He was a deeply religious man. Three of his sons were educated at Princeton. Dr. Samuel Kennedy Talmage became President of Oglethorpe College; and served as first Chaplain of the First Confederate Congress in Atlanta, Ga. David 7 managed the family farm.

DAVID 7\* (s. of Capt. Thomas, etc.) b. April 21, 1783 at Piscataway, N.J. rem. to Somerville, N.J., d. Oct. 27, 1865; m. Dec. 19, 1803 Catherine, dau. Peter and Phoebe Brokaw Van Nest, she b. March 27, 1787 (of another deeply religious family, like the Talmages) d. Oct. 27, 1862; ch. Phoebe 8 b. 1805,

Rev. Dr. James R. 8 b. 1807, Sarah 8 b. 1810, Peter Van Nest 8 b. 1813, Col. Daniel 8 b. 1816, Rev. John Van Nest, D.D. 8 b. 1819, Rev. Goyn (Gavin Mc Coy) 8 b. 1821, Catherine 8 b. 1824, David 8 b. 1826, Mary 8\*\* b. 1828, Rev. Dr. Thomas De Witt 8 b. Jan. 7, 1832.

\*David 7 was elected 1836 and 1838 to the Assembly of N.J. from Somerset Co.; in 1841 he was made Sheriff. \*\*Mary Talmage b. at Bound Brook, N.J. Dec. 25, 1828 m. Rev. Stephen L. Mershon of Somerville, N.J. who graduated from Princeton and Princeton Theological Seminary and whose first parish was the Presbyterian Church at East Hampton from 1854 to 1866; eight of their nine ch. were b. in E.H. They were: Sarah (who m. Ralph Brekaw); Grace T. (who m. F. W. Hannahs,) Daniel T., Stephen Lyon Jr. (who m. Addie J. Hawkins of Moriches and had dau. Mrs. Adelaide Mershon Purcell of Montclair, N.J. and E.H.), Mary T. (who m. Henry D. Ames), David who d. inf.; James, Bessie, Emma Terbell (who m. G. R. Cushman). Rev. Stephen L. Mershon m. 2nd. his 1st wife's niece and namesake, Mary, dau. of Rev. James Talmage; he d. of pneumonia three days later on April 11, 1874, at the age of 47.
