## CONKLIN OR CONKLING FAMILY

THE FIRST Conklin or Conkling (the name is spelled both ways) to settle in East Hampton was Ananias, born in Nottinghamshire, England about 1600. He came to Salem, Mass. in the 1630's with his brother John, perhaps there were other brothers, but certainly John was there. Ananias Conkling is recorded as a member of the First Church in Salem in 1639. The brothers were glass-makers by trade. They were first to manufacture window glass and bottles in New England. They were granted house lots in Salem. Ananias was granted, 1638, a ten-acre plot for a glass factory; this was still known, long afterward, as "Glass House Field." Ananias was made a freeman of Salem on May 18, 1642.

They left New England for Long Island probably late in 1649, John founding a family in Southold, later moving to Huntington about 1660. Ananias obtained an allotment of land in East Hampton, settling here about 1650. Jeremiah, oldest son of Ananias, was one of the first four settlers of Amagansett shortly after 1690. The house he built there is still standing, and was sold 1950 to Mrs. Donald Lamb. Amagansett has been called, facetiously, "Conklinville."

Historians will differ on some points, after 300 years. Chauncey L. Ditmars, Babylon Town Historian, wrote in 1936 about the Huntington Conklins, calling the first settler of that name there "Robert." Frank J. Conkling, writing in 1894, called the first Conklin in Huntington "John." Still another genealogist, Joseph I. Conklin, Jr., stated that there was a third brother named Cornelius who remained in Salem, died there 1667 leaving a widow who later married Robert Starr.

George Miller) and perhaps Joan 2.

\*Ananias Conkling is thought to have owned property later C. P. B. Jefferys' and now divided by Jefferys Lane. The book "Lineal Ancestors of Susan (Mulford) Cory," Vol. 3, Part 1, p. 49, states that Esther, first wife of Capt. Samuel Mulford, was probably daughter of Ananias Conkling by his third wife, whom he married when she was the widow of Robert Rose; and that the daughter was about 4 years old. Since he had a daughter Hester, only about six years old when he died, who is thought to have married George Miller, that seems unlikely. The writer has no proof of any marriage but the first; but there may have been others.

\*Lion Gardiner owned 9½ acres before 1663 between what is now James Lane and Hook Pond. Mrs. Olney B. Mairs Jr. (Isabel Gardiner) is authority for statement that the house there now owned by Winthrop Gardiner Jr. was built for Jeremiah and Mary Gardiner Conckling by the 1st Lion Gardiner. That may well be correct. But it is recorded that Andrew Miller sold, Dec. 2, 1664, his house and land in E.H. to "Jeremiah Concklinge"; and Andrew Miller's land was in about that location, perhaps next door. It is interesting to note that Andrew Miller sold the house but retained for his own use "that pane of glass that is in my house."

Jacob Schellinger and lived at Wainscott.)

\*He lived before 1680 on Main St., E.H., near present home of Mrs. S. J. Lynch.)

JEREMIAH 3 (s. of Jeremiah 2) of Amagansett, b. 1661 d.s.p. Aug. 7, 1734, m. Jane Parsons, she d. April 21, 1741 ae 76. His Will mentions his nephew Elisha 4, s. of Capt. Cornelius 3; and mentions Elisha's s. Jeremiah 5 as his own adopted son; also mentions a great-niece Jane dau. of Samuel 4 deceased.

Stephen Herrick of Southampton Dec. 24, 1719), Rachel 4 b. 1701 d. 1790; Jeremiah 4 bapt. 1707 d. inf.; Mary 4 bapt. 1710 (who m. Obadiah Wells of Southold Aug. 19, 1736)

\*He bought Caleb Osborn property in Wainscott March 23, 1704; was E.H. Town Clerk, 1712-1747.

DAVID 3\* (s. of Jeremiah 2) b. 1667 d. Dec. 4, 1738, m. 1690 Mary, dau. Samuel and Esther Hand Mulford (or Mary, dau. George and Susannah Miller Filer; two authorities disagree). Ch. Jeremiah 4 b. 1695 d. 1719; David 4 b. 1697 d. Dec. 17, 1767; Sarah 4 b. 1698 d. Oct. 22, 1736 (who m. June 17, 1725 Isaac Barnes Jr.) Patience 4 b. 1700, d.y.; Samuel 4 b. 1702 d. April 29, 1726; Simon 4 b. 1705 d. May 30, 1713; Keziah 4 b. 1707 d.s.p. Nov. 22, 1726; Rachel 4 b. 1709 (who m. Daniel Edwards Jan. 12, 1736), Temperance 4 b. 1712 (who m. Timothy Miller Oct. 30, 1734); also mentioned in the Will of David 3 are a dau. Jane 4 bapt. 1714 (who m. Henry Sherrill Nov. 4, 1736), and s. Daniel 4, who was an executor.

\*David 3 and David 4 lived in Amagansett, on what was known in the 1890's as the Theodore Conklin place; it became the Amagansett telephone central office in the 1920's.

Abraham Pierson 1720 and had ch. William, Zebedee, Abraham, Elizabeth, and d. before 1747), Lewis 4 bapt. Jan. 18, 1702, Esther 4 bapt. Sept. 3, 1704 (who m. David Baker Feb. 3, 1726), Mary 4 bapt.

1708 (who m. Nov. 12, 1734 Thomas Dibble Jr.), Mercy 4 bapt. 1710 (who m. John Miller Jr. 1733), Isaac 4 bapt. Jan. 25, 1713, d.s.p. July 4, 1744 (he was buried in the woods at Fresh Pond); Zerviah 4 bapt. 1716 (who m. 1738 Samuel Mulford Jr.), Sineus 4 bapt. Oct. 19, 1718, Abigail 4 bapt. 1721 (who m. John Cooper 1720), Mary 4 bapt. 1704, d. inf.; Benjamin 4 (perhaps), Hannah 4 bapt. 1707 d. 1720; Joseph 4 bapt. 1709; Zerviah 4 bapt. 1711 d. inf.; Martha 4 bapt. 1713, d. 1715; Ananias 4 bapt. 1716, d. inf.

\*Ananias 3 was a Justice of the Peace.

\*Rev. Nathaniel Huntting noted that Mary was "ye 1st ch. baptized in ye new meeting house."

WILLIAM 3 (s. of Cornelius 2, Ananias 1) b. 1695, d. 1761, m. Ruth, dau. John and Ruth Stratton Hedges, Nov. 26, 1717; she b. 1698 d. 1785; ch. William 4 bapt. 1719, Stephen 4 bapt. 1721, Mary 4 bapt. 1724 (who m. John Chatfield), Abraham 4 bapt. 1726, Ruth 4 bapt. 1728 (who m. Cornelius Conklin May 6, 1748), Jacob 4 bapt. Aug. 20, 1732, Isaac 4 bapt. 1732 d.y.; Abigail 4 bapt. Jan. 22, 1734 (who m. Jacob Hand and lived at First House, Montauk, buried there), Thomas 4 b. 1739 d. March 1753.

JOHN 3\* (s. of Benjamin 2) b. 1669 d. April 28, 1745/6 ch. John 4 b. 1693, and the following, all baptized as adults: Rachel 4 bapt. 1718/19, (who m. Sept. 21, 1721, Daniel Jones;) Amy 4 bapt. same day, (who m. Dec. 29, 1720 John Stratton); Timothy 4 bapt. May 30, 1723; Abigail 4 bapt. Nov. 26, 1727 (who m. Nov. 22, 1733, Gideon Hedges); Elias 4 bapt. 1727; Jonathan 4 bapt. 1734. The Will of John 3 mentions only John, Elias, and Jonathan.

\*Dr. Finch's notes say that John 3 was a shoemaker.

Feb. 22, 1702 (who inherited houses and land), Mary 4 bapt. 1704, Nathan 4 bapt. 1705, Ananias 4 bapt. 1708, Samuel 4 bapt. Jan. 27, 1711 d. 1712; Lemuel 4 bapt. 1713, Hannah 4 and Benjamin 4, twins, bapt. 1715; (Hannah 4 m. March 7, 1736, Isaac Barnes), Daniel 4 bapt. 1718, d. Oct. 26, 1800; Josiah 4 bapt. 1721. Ananias 4 and Lemuel 4 received 6 shillings each, in their father's Will.

ELIAKIM 3 (s. of Benjamin 2) b. 1685 m. Deborah Stratton June 22, 1708; he probably moved to Wainscott; ch. Deborah 4, Sarah 4, Eliakim 4 who d. May 5, 1746 ae 33.

ELISHA 4 (s. of Capt. Cornelius 3, Jeremiah 2) b. March 15, 1690 in E.H., rem. to Wainscott; d. Feb. 15, 1772; m. Jan. 1, 1718 Esther Parsons, she b. 1698 d. Oct. 26, 1756; ch. Elisha 5 bapt. May 1, 1720 d. 1804; Jeremiah 5 b. 1722 d. 1746; Nathan 5 b. 1724 d. July 16, 1776 (Dr. Finch says Oct. 9, 1746); Jacob

- 5 b. 1726 d. 1753; Esther 5 b. 1728/9, d. 1800 (who m. Capt. David Fithian Dec. 1746), Lucretia 5 b. bapt. 1732, d. Jan. 5, 1739; Mary 5 b. 1735, Mehitabel 5 b. 1737, Eleazer 5 b. 1740.
- JEREMIAH 4** (s. of David 3) b. 1695, "he was drowned a-whaling" Feb. 24, 1719, off the beach here. With him were a Schellinger, a Mulford, and a Parsons. His s. Jeremiah 5, was b. 1719 bapt. 1727; his widow, Jane Parsons Conkling, m. Giles Gardiner Oct. 3, 1728; she d. Feb. 7, 1759.
- DAVID 4** (s. of David 3) b. 1697 d. Dec. 17, 1767; he m. Dec. 8, 1720, Hannah, widow of Lewis Mulford; she b. 1696 d. Dec. 7, 1769, dau. Seth and Sarah Conklin Parsons; ch. David 5 b. 1721, Simeon 5 b. 1724, Samuel 5 b. Feb. 19, 1726, d. May 1, 1802; Hannah 5 b. 1728 (who m. a Dayton), Zebulon 5 b. 1732, Sarah 5 bapt. 1735 (b. 1731) d. April 14, 1784 (who m. 1st a Conkling and m. 2nd. Capt. Francis Pelletreau).

- LEWIS 4** (s. of Lewis 3) bapt. 1702, m. 1721 Elizabeth Mulford and d.s.p.
- SINEUS 4** (s. of Lewis 3, Jeremiah 2) bapt. Oct. 19, 1718, d. May, 1810 ae 94, m. Dec. 20, 1744 Clemence Ayres or Eyres; ch. Mary 5 b. 1744 (who m. 1st Jeremiah Hedges of E.H. and m. 2nd. 1800 Thomas Tredwell and is buried in Clinton, N.Y.), Isaac 5 bapt. June 2, 1747, Benjamin 5, Elizabeth 5 bapt. 1760, Phebe 5 bapt. 1764 (who m. Silas Edwards and settled in Conn.), Jonathan 5, Joseph 5 (who rem. to Conn.), Nathaniel 5 (who rem. to Lyme, Conn. and m. The evening of Dec. 23, 1811 was mild, hazy, with some fog. It was so warm that horses were left in pasture all night; a teamster at Water Mill had brought a wagon load of oysters from E.H. at 9 p.m. and left them outdoors, thinking there was no danger of freezing. About 1 or 2 a.m. a sudden blinding northeast snow-storm began. The mercury fell to 8 degrees; wind increased almost to hurricane force. It raged 24 hours. Thompson's History of L.I. said that more than 60 vessels were cast ashore on the north side of L.I., many were driven on Lloyd's Neck, Eaton's Neck, and Gardiner's Island; an immense amount of property was destroyed and many lives lost.

Mrs. Theodore Conklin told the writer, years ago: "Our old silver has the letters N&E Hand, the custom in those days. Each daughter in the Hand family on her marriage had a bureau, a table, six chairs, linen, silver, china, a cow, six sheep, and a man servant given her. Rebecca's man was old colored Cato."

**STEPHEN RAYMOND 9** (s. of Stephen Roland 8) b. April 10, 1893, m. 1st Elsie Joan Peiken of N.Y. Nov. 25, 1918, div.; he m. 2nd. Clara Harriet Everett of Maine, May 12, 1939, she d. Oct. 7, 1951. He m. 3d. June 14, 1952 Alice Marie Terry of Terryville, N.Y.; no ch.

\*The family lived in Bridgehampton in E. Marvin Conklin's boyhood and he knew Judge Henry P. Hedges, author of E.H. History 1897. Mr. Conklin has kept a paper written for him in 1910 by Judge Hedges, stating that he is a Son of the Revolution because his great-great-grandfather Elisha Conkling of E.H. signed the agreement to stand by the cause of America in 1775.

May 27, 1897 Caroline, dau. William and Althea Edwards Baker, she b. July 15, 1878 d. June 28, 1933; ch. Jeremiah Austin 11 b. March 12, 1890, d. June 17, 1915; Eleanor Baker 11 b. Sept. 26, 1906 (who m. Oct. 16, 1924 David Talmage; see Talmage genealogy). Mr. and Mrs. Talmage were last of the family to live in the old house—see p. 1, Conkling genealogy. The first Amagansett Post Office was in this house.

## THE SOUTHOLD-HUNTINGTON CONKLINS OR CONKLINGS

No more than a mention can be made of the Conklins outside of East Hampton Township; they are of the same blood, but another story. They begin with:

JOHN CONKLIN 1 m. 1st Mrs. Elizabeth Allseabrooke, 1624, in St. Peter's Parish, Nottingham, England; and m. 2nd. in America Mary, surname unknown. He was in Salem, Mass. in the 1630's; in the village of Oyster Ponds (later Orient), town of Southold; and later in Huntington, L.I. He d. Feb. 1684. Ch. John 2, Jacob 2, Timothy 2, Rebecca 2, Elizabeth 2.

JOHN 2 b. in England, d. in Southold April 6, 1694; ae 64; he m. 2nd. Sarah, dau. Barnabas Horton and widow of William Salmon, ch. John 3, Henry 3, Thomas 3, Joseph 3, Sarah 3, Rachel 3, Mary 3, (perhaps) Elizabeth 3.

CAPT. TIMOTHY 2\* (s. of John 1) b. 1640 d. 1720 had ch. John 3, Timothy 3, Jacob 3 b. 1675, Cornelius 3.

\*Capt. Timothy Conkling was a sea captain and ship owner.

JOHN 3 (probably s. of Capt. Timothy 2) lived in E.H. and m. Rebecca Talmage Dec. 17, 1717; they had ch. John 4 bapt. in E.H. March 22, 1719, Rebecca 4 bapt. 1721, Nathaniel 4 bapt. April 22, 1722, Abigail 4 bapt. 1724, Keturah 4 bapt. 1726, Martha 4 bapt. 1728, Joseph 4 bapt. 1730, Enos 4 bapt. 1732, Mary 4 bapt. 1733. The following probably refers to the wife of this John 3: "Rebecca, widow of John Conkling, m. Jonathan Gore of Goshen, N.Y. 1745."

CAPT. JACOB 3\* (s. of Capt. Timothy 2) b. in Huntington, L.I. March 15, 1675, m. May 14, 1701 Hannah Platt of Huntington; ch. Col. Platt 4 and Capt. Nathaniel 4.

\*Capt. Jacob sailed involuntarily with the pirate, Capt. William Kidd. Conkling was cruising in L.I. Sound on board a merchant schooner in 1699 when along came Kidd in the "Adventure". Kidd sank the merchant schooner and compelled the 25 year old Conkling to join him. Sent ashore at Cold Spring Harbor to gather supplies and fill water casks, Conkling escaped. He lived to be a very prominent citizen and his sons held high office in town and county. Capt. Kidd was hanged, some consider unjustly, in London on May 24, 1701.

Mrs. John Williams of 1770 House, E.H. was born Meta Conklin, one of the "Southold Conklins".

Amagansett descendants of John Conklin 1 of Southold are:

\*He is credited with naming "Louse Point". He said that Connecticut people who came over there fishing almost starved to death; "not enough there to feed a louse."

FRED STANLEY 8 d. March 22, 1942 m. Mabel Miller; she d. Aug. 16, 1945; they adopted a s. John Logan Conklin 9 of Amagansett, who is a Bay Constable for the Town.

FRANCIS ELTON 8 b. Sept. 19, 1888, d. Sept. 7, 1916, m. Frances Hammond; ch. Elton B. 9 who d. inf. 1913; Barbara Mae 9 b. Jan. 31, 1914 (who m. Benjamin F. Tyler 1932; has ch. Frank C. b. 1933, Theresa b. 1934 d.y., Nancy C. b. 1935, Benjamin D. b. 1938, Joanna E. b. 1951) Frank Elton Conkling's widow m. Dr. Frederick A. Finch.

JOHN LOHMAN 9 m. Marietta King Oct. 30, 1943.
