THE FIRST Hedges in East Hampton is thought to have come from Maidstone in Kent, England. The name still appears regularly in the Kent Messenger, newspaper published in Maidstone; and the name is still well represented here. Kentish records going back for centuries spell the name variously, Hedges, Hedge, Hodge or Hodges.

Judge Henry P. Hedges, 19th century East Hampton historian, considered William Hodges who settled Taunton, Mass, in 1643 the same man who arrived in East Hampton by 1650 by way of Southampton and whose name was spelled Hedges here.

William Hedges was granted land in 1652 which remained in the family until 1923. The Hedges Inn, built about 1770 on the site of an earlier house, is located on property described in the 1652 grant as being on the "Great Plaine, more or less bounded with the hie way South, the litell Pond West, and the hie way North and John Mulford East."

Hedges men have served East Hampton Township as Supervisor, David Hedges Jr., John C. Hedges, and Stephen L. Hedges; they have been Town Clerks, Stephen L. Hedges, John C. Hedges, Howard Hedges and Arthur Hedges. The late Samuel C. Hedges (1870–1952) was Village Trustee at one time, and member of the three-man board which formulated the original Zoning Laws for the Incorporated Village of East Hampton. He was President of the East Hampton Historical Society and active in three celebrations of the town's founding, in 1899, 1924, and 1948. His nephew, Kenneth Hedges, has served as Village Trustee and is now a Town Assessor.

The Suffolk County "Portrait and Biographical Record" of 1896 says that Hedges men have been largely farmers and with few exceptions have made a signal success of it; also they are notable for longevity, averaging 85 years with near-centenarians not uncommon.

It may be added that they often exchanged the plow for the whalingirons. A Hedges (Tristram or William, the old records are dim and historians say the given name may be either; it was probably William) in March, 1644, was named as a member of the first organized whaling company in America. Forty-four men banded together at Southampton to take care of the valuable right whales off the beach on easten Long Island.

Whaling captains Jonathan, Jeremiah, Hiram, and William H. Hedges were among those sailing out of Sag Harbor for nearly a hundred years, 1780–1875; and nobody knows how many more shipped on whaling vessels in lesser capacities.

Some of them dropped their whaling irons in 1849 when the news of

gold in California stripped eastern Long Island of her young and enterprising men. One Job Hedges was on the Sabina, an old whaleship that sailed out of Sag Harbor around Cape Horn bound for San Francisco. Every man in the Sabina's crew was a whaling captain and they elected their master for that voyage. But most of the Argonauts came back to resume farming and fishing operations at home.

Members of this family who have settled elsewhere, attaining prominence in various fields, have kept a warm spot in their hearts for the old home town. Judge Henry P. Hedges, born in East Hampton and schooled at Clinton Academy, lived and practised law in Bridgehampton; but returned to make the principal address at two anniversaries of East Hampton's founding, in 1849 and 1889; was one of a committee to publish East Hampton Town Records, and himself wrote and published, 1897, an East Hampton History. His kinsman, Dayton Hedges, now of Havana, Cuba is honoring Judge Hedges' memory in publishing this new history and genealogies, and expressing his own affection for the first American home of his ancestors in a very concrete way by his gift to the East Hampton Library.

THE FIRST HOMESTEAD

Thanks to a series of old account books dated 1725 to 1812 it is possible to trace definitely the eight generations of the Hedges family who lived where the Hedges Inn stands, 1952. Before proceeding with the other branches of the family, it might be interesting to trace the history of the old homestead. Mr. and Mrs. John D. Hedges, still well remembered in East Hampton, had only one son, Daniel, who died in 1894 at the age of twenty-three. After Mr. Hedges' death in 1918, his wife lived on there alone until she died in 1923. Then the house was sold and became briefly a roadside restaurant with a huge sign. Mrs. Harry L. Hamlin, who had bought and restored several other early East Hampton houses, and who knew and loved Mrs. Hedges, felt this an indignity to the fine old home and an unsuitable approach to the village; the location at the head of Town Pond being entrance for all motor travel from New York. So she bought it and made additions and turned the house, a boarding house in summer since the 1870's, into a small beautiful inn, opened 1935.

Mrs. Hamlin explored a small shoemaker's shop still standing at the rear of the place. She found books and papers showing its use and its approximate age. The Hedges men must have been working in leather from about 1700, tanning the leather, manufacturing shoes, saddles and harness. Shoes of Hedges manufacture were sent as far as New York, Newport and Nantucket. Women of the village worked on the shoes at home. The old account books were given the writer by Mrs. Hamlin, and are being preserved in the East Hampton Library. John Hedges 3, John 4, Daniel 5, and John N. 6 kept the account books. John Hedges 4 kept a

limited drugstore as well as selling shoes. He charged for "tinctor" and "phisick" and to "salve and dressing a soar, sixpence."

Daniel 6*—not mentioned in any genealogies—who must have been one of the older children; discovered only lately through letters found in The Hedges by Mrs. Harry L. Hamlin. Josiah 6 d. 1769, an infant; and William Rysam 6 who d. June 21, 1793 ae 1 yr. must have been the "little son of Daniel Hedges" who was "drownded," in 1793.
- *Among other old Hedges papers are eight letters written by Capt. Daniel 6 to his "Honour'd Parents," Daniel 5 and Jerusha Huntting Hedges between 1794 and 1799. His ship, the Severn, was captured 1794 by the Proserpine frigate and taken to France. He said "If I ever get my feet in New York again I will not leave it till there is a better law carried on between the nations." But he did. He wrote Jan. 1795 from Brest ("this hole"); and he went back and forth to Europe via Honduras. In 1796 he was again captured and plundered by the French; taken to Cuba and Hispaniola. In 1799 he was master of the "Molly" of N.Y., a command he secured through his uncle by marriage, Capt. William Rysam of Sag Harbor.

OTHER BRANCHES OF THE EAST HAMPTON HEDGES FAMILY

- ISAAC 2* (younger s. of William 1) b. 1637 d. 1676. On March 7, that year, letters of administration of his estate were granted. His young children were mentioned but not named. He m. 1660 Joanna, dau. of Joshua Barnes of Southampton who later rem. to Westchester Co., N.Y. She d. June 6, 1706. Of their children, Judge Hedges mentions only a son, Isaac 3, b. 1664; but their dau. Joanna Barnes 3 married in the late 1600's, Abraham Schellinger.
- *Isaac was one of the men appointed to keep the dry herd at Montauk, 1662; in 1664 was engaged as Town drummer at 40 s. per annum.
- It is possible that Isaac 2 had s. Ebenezer 3, who had a s. 4 and dau. Abigail 4 who m. Jeremiah Mulford 1713; this son 4, or perhaps another generation later, had the Ebenezer who m. 1740 and d. 1768, having s. Ebenezer b. 1751.
- DANIEL 3* (s. of Stephen 2, William 1) b. 1677 d. June 11, 1734, m. Sept. 20, 1702/3, Abigail, dau. Nathaniel Baker; she d. Nov. 1, 1773 ae 92; ch. Daniel 4 b. 1708 d. April 12, 1766; Jonathan 4 b. 1724, Mary 4.
- *He bought the Daniel Sayre homestead, later Miss Mary Cooper's, and founded the "Sagg Hedges" family for whom Hedges Lane is named.

Finch says that Ruth 4, dau. Isaac 3, m. William Conklin Nov. 26, 1717. Judge Hedges does not mention this daughter.

*Note: S. H. Finley, whose wife was a g.g.g.g. granddau. of Stephen Hedges 4, says he d. 1801 (or 1760). E.H. historians say 1760.

*The late S. H. Finley of Santa Ana, Calif. in 1934, prepared a chart of the Finley family and gave one to the E.H. Free Library. He, Solomon Henderson Finley, married Ida Hedges on Jan. 8, 1891, she b. July 19, 1870 at Cambridge, N.Y., dau. Samuel Hedges (1829–1926) and Elizabeth Talford; granddau. Samuel Booth Hedges (1786–1854) and Mary Baker of Washington Co., N.Y.; she also descended from an old E.H. family. The line goes back to Stephen 4, John 3, Stephen 2 and William 1 of E.H. Matthew Hedges 5 was a refugee to Connecticut during the Revolution and a member of Capt. Lupton's Company; but he and his wife Naomi and some of their children were buried in the Jericho cemetery in E.H. Mr. Finley said Naomi was the 2nd wife.

*Deacon David Hedges was a remarkable man. He served for 20 years as Supervisor in Southampton Town; was deputy to the 4th Provincial Congress, State of New York, 1776–77; delegate to the Convention that ratified the Constitution of the U.S., and voting therefor; Member of Assembly, 1786, '87, '88, '89, 1804, '06, and '07. In 1807 he was active in securing passage of an act incorporating the Proprietors of Montauk, a complicated business which met with some opposition (see Hedges' E.H. History, p. 298).

During the Revolution the Bridgehampton Church had no minister; then and often in later life in the minister's absence he would conduct public worship and read a sermon. At the close of the Deacon's preaching on July 2, 1775, John Hulbert gathered the men of the congregation about him at the church door and there enlisted 21 men for one of the first companies organized in the colony for

the defense of national liberty.

Quoting Judge Hedges: "He was physically powerful, and capable of great endurance. It is reported that he took a drove of cattle to New York and sold them for a thousand pounds. In those days robberies were frequent and the danger therefrom alarming. To avoid it Deacon Hedges took this large sum in his saddle bags, started on horseback from Brooklyn Ferry before daybreak, and stopping for refreshments only once on the road, arrived at his home in Sagg safely by 9 o'clock in the evening, a distance of 100 miles. Tradition tells that the Deacon was none the worse for it, but the young horse he rode was a long time disabled. There is a tradition that at one time the State government offered a bounty or premium to the man who would raise the most flax. In the hope of procuring the premium he sowed forty acres in one field. He led the company in pulling it, and when they got around it, Levi Sandford, one of them nearest to him said, 'Deacon, we have been around the world.'"

Author's note: Deacon David Hedges built the house on Hedges Lane, Sagaponack,—a street that was once all Hedges houses—which was owned by the late Samuel C. Hedges of East Hampton. Last of the name to live there were the Misses Esther and Ann Hedges, 8th generation. They were cousins of my grandmother, Phoebe Jeannette Osborn Huntting. I often called on them, two jolly little old ladies who wore slat sunbonnets to tend their garden and their chickens.

Cousin Ann told me that Deacon David, her great-grandfather, could walk from Sagg to Wainscott on his own land. When he was away at the Legislature he left his slaves to manage the place. He had a big family of slaves, descendants of one Adam who came as a child of 5 from the Congo; five children were born to him on the place and Miss Hedges' father built a house for his son John who drove their oxen when she was a child. The slaves were liberated in 1828, she said. Wilkes Hedges' Bible recorded births of three slaves---John, in May 1801; "Vilet," May, 1803; and Kingston July 30, 1805.

Note by H. P. Hedges: "Col. David Hedges was a man of unusual intelligence, good judgment and strong common sense. He served the public as a silversmith all his life. His house, and shop next south of Clinton Academy were the resort of those seeking counsel or social enjoyment. He had many strong friends. He represented Suffolk Co. in the Assembly in 1825, 1829, 1833. He held many Town offices beside that of Supervisor. Few men have enjoyed more fully the respect and confidence of their fellow men, and deservedly so. His son John Chatfield Hedges, M.D., although of sweet, modest, retiring manner, was like his father in intellect, judgment and good sense; an omnivorous reader, an untiring antiquarian, an attractive companion. No descendant perpetuates their light. The fragrant memory of their virtues and their friendship yet survives. This tribute to their worth, the writer, their kinsman, is impelled to record."

(see Fortune, June, 1941; and Reader's Digest of July, 1943).

In 1919 pioneering was possible in Cuba. It was a one-crop (sugar) country. He built a large textile mill complete with modern village, including a school, restaurant, shops, dispensary and clubhouse, and free housing for a large number of families among his 3,000 workers according to seniority. In 1937 he instituted a six-hour working day, something unheard of in Cuba at that time. He is the adopted son of three Cuban cities and the name of another town has been legally changed to "Dayton Hedges." He has been decorated several times by the Cuban Government and is the holder of Cuba's highest decoration. On May 20, 1943 a bronze bust of Dayton Hedges was unveiled with great ceremony in the park square at Bauta, a gift of the mill workers and school children. In 1948 he built a rayon factory in Matanzas, Cuba. No cotton having been raised in Cuba since slave days, it was necessary to import cotton for his mill. In 1952 he bought a large ranch and began to grow cotton by modern methods. He also is the owner of Cayo la Rosa—a large ranch where he raises beef cattle.
